It also provides pen-alties for the violation of the law of a fine not exceeding \$1000 or imprisonment not exceeding one year, or both to the discretion of the President. If this bill were a law it would break up every organization in the United States which bears arms of any description and is not a part of the militia of some of the States. It would, however, be unconstitutional.

The force has consisted of the marshal and chief of police, two sergeants, two deenier of police, two sergeants, two detectives, two mounted patrolmen, eight patrolmen, and a day and a night failor. The number of arrests during this time reached the sum total of 714. Of this number, 152 were discharged, 5 turned over to the sheriff, 7, to the United States marshal and 5 other officers outside the Territory. other officers outside the Territory The offenders committed served 3240 days.
