FORMAL CHARGE OF MURDER MADE

DISTRICT COURT BUSINESS.

O. S. P. & Clay Co. Gets Judgment for

Ogden, Oct. 26.—The formal charge against F. C. Walker and Ed. Lawrence of murder in the first degree has been filed in the second district court by District Attorney George Halverson, and Judge Maxwell has set down the arraignment for Monday, Nov. 4, at 10 a.m. The transcript of evidence from the law suit has been filed also, so that all papers are in readiness now for the petition to be made by Atty. Halverson for bail for the two defendants. Just when the case will come on for trial is not known, but it will be at the earliest possible date, as both the defendants and the state are anxious to get the case decided. The names of all witnesses are attached to the petition, among them being Mrs. Gertrude Hall and daughter, who will be brought to Ogden from Nevada, as their testimony is the most damaging the state has to present against the defendants; the case against Elizabeth J. Carter, against the Utah Construction company, to recover damages was dismissed on the ground that the plaintiff was not a resident of the state and failed to put up security for the cost in the case, as the law requires.
