Iowa City Wins Out in Race Against San Francisco, Denver and Atlantic City.

CONTEST WAS SPIRITED ONE

Two Candidates Named for President of Brotherhood—Sec'y and Treasurer Without Opposition.

At yesterday's session of the biennial convention of the United Brotherhood of Carpenters and Joiners, Des Moines was named as the place for holding the convention for 1910. Des Moines won out in a race with San Francisco, Denver and Atlantic City. The vote was 142 for Des Moines, 131 for San Francisco, 10 for Denver and 1 for Atlantic City. The two other competing cities were Denver and Atlantic City. The former drew 101 votes and the latter 43. Des Moines made its claim good through its location
