

## HEIR TO A FORTUNE.

Salt Lake Printer Comes in For Shares of a Large Estate.

### SURMISED TO HIS NATIVE LAND

By an Order of Court, to Receive One Third of the Property Left by Wealthy Parents.

Peter Hansen is a resident of this city, and by trade a carpenter. He is an unassuming, pleasant man, who is highly respected by those who know him, and that means a great many, for he has been Danish consul in this city for a number of years past. Mr. Hansen is a native of Skive, Denmark, and emigrated from that place to Utah twenty years ago—in 1875. In the city he first took up as a carpenter at the Juvenile Instructor office, where that journal was published at its old quarters, on South Temple street, west, and George C. Lambert was manager.

After a time Mr. Hansen thought he would try his fortune in the farming district, and removed to Mantua, Sanpetueme. He remained there six or seven years, when he again concluded to cast his lot in the metropolis, and with his increasing family again came to Salt Lake. Here he was engaged as a printer at the Deseret News office, on Main Street, then being published by Andrew Jameson, and on other works, both English and Danish.

Mr. Hansen next found employment as a member of the Salt Lake City department, and filled an important position for a few years until his removal from city administration in 1889, when he again returned to practicing at the law.

On several occasions he had been asked to represent the Danish consul general at Chicago, in settling disputes between Danes who were being sought for in Utah, and when a consul to represent Denmark in this Territory was wanted his name came to the front. He received the endorsement of his countrymen, and was chosen, and obtained the appointment from the Danish minister in Washington in February, 1892.

As usual, Mr. Hansen is making a satisfactory living, and has been of service to many people here in the settling up of estates alone there has passed through his hands for his countrymen in this part of the country more than \$200,000.

He also has secured over one thousand names for people who were making up their family records.

Mr. Hansen's father was Hans Peter Nielsen. By the rule of inheritance of most who are unable to trace their genealogy in this country which seems strange and continuing to pass unconquered there, the first Christian name of the father becomes merged in the surname of the son. He died in 1866. Hans Peter Nielsen's son is Peter Hansen.

There were three children in the family, Mr. Hansen being the oldest, and the only son. The others were Hans and Charlotte, and both are now in the service of wealthy business men in the native land. The husband of one is a dry goods merchant, and that of the other is in the shipping business in the English trade.

Mr. Hansen stood high in his native town, being one of the leading politicians of the day.

He has been a member of the city council, or party of the left, and was for many years a member of the Salt Lake City council. He carried on a large business as dealer in lumber, hardware, agricultural implements, and also owned a farm a little outside the city. During the greater portion of his life he was robust in health, but for the past five years he has been an invalid.

When Mr. Hansen decided to move to America he did so with the best upon favorably by his parents. His father was of a kindly disposition, but at 50 years of age he was half and vigorous, and the first result of his only son to change a resort to go in America was to break his heart.

He died in 1866, leaving his wife,

and two sons, Hans and Peter, who learned of the death of his father.

That which caused him to decide to go immediately was a summons from a Danish law court requiring his presence in his native land to settle up the estate of which his heir is heir to one-third, and which is worth from \$50,000 to \$75,000 at least. The call to go came a few days since, and the now arraigned master is at work in the law office of his son, who has agreed to return to May next.

The many friends of Mr. Hansen who know his honesty and worth as a citizen will feel to congratulate him and wish him a safe journey going and returning. He did not go without some regret, but his companion reported him to be much comforted in the presence of a parson. The elderly therapist, turning not to Dr. Dennis, but to the old elder, said, "You think I'm going to hell, don't you?" "No," said the elder, "I have not," and dismissed No. 2 with a conviction in reply to a charge of trifling. From his trifling he must be a Universalist."—New York Sun.
