Business.

New York, 30.—The Public's
statement of exchanges for the
week ending June 18, at San Fran-
cisco and 25 other cities, shows a
business increase of 10 per cent,
and over at 17 of the twenty cities,
from which returns are given, as
compared with the corresponding
period last year. Outside of New
York the aggregate closely approach-
ed \$300,000,000.

Preparing for Requisition.

The Times' special says: Inspec-
tor Byrnes was engaged yesterday
in preparing papers on which to ob-
tain a requisition from Governor
Cortell for the return to this state of
Hops. Superintendent Walling sent
a dispatch yesterday to the chief of
police, San Francisco giving an ac-
count of what they are entitled for
this city, and requesting that if
the charge now pending against him
in San Francisco be not sustained,
he be detained until officers can be
sent to bring him to this city, as
soon as the warrant issued and the
papers are in due form, officers will
be sent to San Francisco. Should
the charges against Hops, on which
he is arrested, be sustained, he will
be tried on them and the requisition
from Governor Cortell will be lodg-
ed as a detainer against him, so that
he may not escape should he be ac-
quitted. Inspector Byrnes thinks
there is a fair prospect of Hops being
brought to this city, and deems his
condition, if tried here, a favorable
conclusion, as the evidence against
him is strong to be controverted.

WASHINGTON, 30.—Ex-Secretary
