Clashing Opinions on the New Jail Specification.

KELSEY ON BOULEVARD MATTERS.

Wantland After the Osmarparian Debris.—Temporary Arrangements for Sprinkling.

An adjourned session of the City Council was held last night. Councilman Leibowitz being absent, Councilman Maran was chosen chairman of the meeting. The members passed several by-laws, Board of Health, Rich, Lewellen, Hays, Harriet, Rich, Lewellen, Kelly, Hays, Evans, Hinman.

President Leibowitz said in what business was well under way, but advised Mr. Maran to keep the chart.

The Proceedings.

A lengthy set of specifications draws up and presented by Health Commissioner Boddy, for the removal and disposition of garbage from the streets, avenues, alleys, vacant lots of the city, was read and referred to the committee on municipal laws.

NEW JAIL SPECIFICATIONS.

The qualifications of labor and material required for the erection and completion of a new city jail to be built according to the drawings furnished by William Carroll and under his personal supervision, was read.

These specifications cover twenty-two pages of closely type written matter.

Councilman Horn insisted upon the following letter being read from the Van Dorn Iron Works company and the Eagle Foundry and Machine company:

"We desire to call the attention of the City Council to the fact that a communication was presented by the agent of the Stewart Bros. Works, in effect, that the City of Salt Lake City had no right to accept the plans we submitted, submitted specimens with them but, after examining the same with their scientific knowledge, they did not understand the glass and specifications nor were they impressed or made to believe how and the amount of work required to complete the same. The Van Dorn people to our firm with a simple request to them to forward us a bill on their account so that we may be in a position to make payment to you. This was done by them, and as these people are in every respect responsible, their rating being No. 1, and we may have paid them \$100.00 for their services. The City to make up, we enclose the honorable gentleman who concerns the committee that the work will be done to the satisfaction of the city, and that no charge will be made in the bidding as far as the iron work is concerned."

PICKED TO PIECES.

In this connection from A. L. Hinckley, city building inspector was read:

To the Honorable Mayor and City Council:

Gentlemen—My request I herewith submit a report of my findings as to the specifications of iron work on the new jail.

1. The size of plates under "H" beams are not given.

2. Sizes of plates under columns are not given.

3. Connections between beams are not given.

4. Weight and size of iron brackets supporting galleries and the like are not given. The dimensions of iron used in the construction of lattices and other doors, corridor gratings and windows, gratings are not mentioned, except it is to be understood that all of these items were to be supplied by the contractors.

5. Specifications for covering ceiling shaft.

6. Sizes of gallery ceilings not specified.

7. Sizes of anchor bolts, nuts, washers and other hardware not mentioned in the specifications. Would be extra.

8. Iron ventilating stock shown in the plans are not mentioned in the specifications. Indefinite.

9. No specifications for iron stairs.

10. No specifications for covering ventilation shaft.

11. Sizes of gallery ceilings not specified.

12. Sizes of anchor bolts, nuts, washers and other hardware not mentioned in the specifications. Would be extra.

13. It would be impossible for any one except the architect to determine what the iron fittings were intended to do.

14. Sizes of iron rods and wire mentioned in the specifications are not mentioned in the specifications. Extra cost or wrought iron.

15. Referred to the city engineer and building inspector.

SPRINGFIELD INSPECTOR UNQUOTE.

The following by Harrison was added:

Resolved, That the committee on specifications report to the Council at the next regular meeting the boundaries of a sprinkling district and the estimated

cost of equipping the same, also and expenses authorizing the very amount of a special tax for sprinkling purposes.

TEMPORARY ARRANGEMENTS.

The following resolution was also referred to the council:

Resolved, That the committee on sprinkling districts and boundaries be authorized to make a temporary arrangement for sprinkling and report the same to the Council at its next regular meeting, and any contract made by the committee shall be ratified by the council.
