After the 1st day of January and on or before the second Tuesday in July of each year, the assessor shall ascertain the value of all property in the city subject to taxation, and the value of the same shall be ascertained by the assessor in accordance with the provisions of the constitution and laws of this state, and shall file and cause to be filed in the office of the city clerk, a list of the same, showing the name of the owner, the location, the value, and the amount of the tax assessed thereon.
