HOUSE.

WASHINGTON, 5.—During the dis-  
cussion Foster contended that vessels  
such as it was proposed to build would  
cost nearly one million each, and said  
the House was entitled to much better  
information than it had received on the  
subject. But proposed the bill on the  
ground that moment heretofore ap-  
pointed for such purpose, was spent on  
worthless ships, which sold in five  
years for almost nothing, even to the  
lowest or highest bidder. If had been  
charged in the Senate, by Edmunds,  
that one vessel had been sold for \$10,  
000, after getting one coat of  
paint, was sold again for \$120,000 in  
the course of a week. Foster opposed the  
bill and criticized the bill in the navy  
department. Garfield offered an  
amendment providing that no contract  
or orders for the construction of these  
vessels be made until full detailed esti-  
mates are submitted to Congress, and  
appropriations made therefor. Sar-  
gent opposed the amendment as dilatory  
and voted against the bill. At the  
conclusion of the debate the previous  
question was ordered, and the House  
agreed to Garfield's amendment, also  
to Banks' amendment, that the num-  
ber of guns should not exceed ten, and  
by 104 to 47, it was agreed to that the  
number of vessels to be constructed be  
changed from six to six. The bill as  
amended passed.

EASTERN DISPARATES.

WASHINGTON, 5.—The Commissioners  
representing both branches of the  
Alabama Legislature are here. That  
representing Governor Lewis and the  
Court House body to-day made an  
interview with the President, who an-  
swered that he preferred that they first  
come with him to the Treasury, Government  
which they will to-morrow. The com-  
mittee representing the capital branch  
make a statement of their case on  
Saturday. While the Attorney General  
will give full attention to the repre-  
sentation of these Commissioners, he  
will not render any opinion nor take  
any other action on the subject. In  
the view of the Government, it is  
fixed to interfere with the political af-  
fairs of Alabama unless something  
should arise under the Constitution of  
the United States to render interference  
necessary.

in this State claim the election of their  
ticket and will endeavor to install  
themselves in office.

MIFFLIN, Pa., 5.—A terrible accident  
occurred on the Pennsylvania Central  
about 10 miles west of Mansfield. This  
was caused by the second section of the  
Central's cars, consisting of one, ran  
into a car of the first section and tele-  
scoped the engine car. Five persons  
were killed and 10 injured. The names  
of the killed are Matthew  
Knowles and W. W. Dants, wife and child, of

a call on the members of Congress  
on Monday next. The following are the most  
important—S. T. Phillips, solicitor gen-  
eral; vice Edison, G. W. Fairman,  
representative of Philadelphia vice Dis-  
trict; Brigadier General Irving Mc-  
Dowell, to be Major General; H.  
K. Howell, judge of the Supreme Court  
of Missouri Territory.

The Liberal Republicans are desirous  
of having a committee to discuss with regard to minority representation in  
the Senate committees. The Dem-  
ocratic Senators are also caucusing.  
The majority leave only one vacancy in  
the foreign relation committee. The  
Democrats and liberal Republicans  
Senators have agreed among themselves to  
name Schurz as the member of the commit-  
tee. The foreign relations committee  
Chairman on the Indians, Bayard,  
Finance. Cassier, Trumbull and Fenton  
are retiring respectively, as the  
majority leave only one vacancy on  
each of them to be filled as before-  
referred by the opposition.

The Republican caucus will meet to-  
morrow to ratify the selection of its own  
committees with the exception of the  
selections and list will then be ap-  
pointed in open Senate for adoption.  
Edmunds has become chairman of the  
judiciary committee, vice Trumbull,  
Hamilton, chairman of the mining

EUROPEAN.

deputies of the right, representing  
the 30 states, and eleven  
deputies of the left, representing 333  
votes. What course the government  
will take in this connection at this time  
is unknown.

complied with.
