

A FORT DOUGLAS OFFICER.

Report that His Honor is ill and that he will be buried.

An Expressman's Report that Captain T. W. Hartson is the new Executive Officer at Fort Douglas.

The following Associated Press dispatch comes from the San Fran newspaper of state affairs in this city and Fort Douglas being frequently mentioned was pronounced by some less interested in military affairs, as to what the authorities or "A leading paper" will say. Private dispatches from Washington say that the racing heart of the army department will receive orders to go into action immediately, and that a panic is to be avoided entirely. Although it is not difficult to see, it is inferred that the man selected is connected with the cavalry, stationed at Fort Douglas, Utah, two quarters of the original force to be detailed.

Inquiry in Fort Douglas today showed a general absence of anxiety among the men of the unit there and that the report proved a false alarm. That which was informed on the military matters of the post was confined to the fact that Captain T. W. Hartson has been appointed Executive Officer to replace Major Joseph C. Lofland who is a portion of the State of New Mexico was added only to the Southern Pacific west of Ogallala, entering the Colorado River. It is quite generally known that such information from the sources were very scarce and that at times no material news could be obtained. Should these reports prove to be true there would be great relief to the command from the lack of Captain Morris' usual care in difficult circumstances.
