CHOIR MAKES PRESENTATION.

Honors Vice President in Appreciation of His Labors in Its Behalf.

DEATH OF MRS. E. J. WATKINS.

New Huntsville Corporation to Establish Creamery and Deal in Livestock, Etc.

Ogden, June 1.—Vice President Charles J. Ross of the Ogden tabernacle choir was the recipient of a beautiful gift last evening from the choir, in honor of his faithful, untiring efforts in helping to make the Ogden tabernacle choir second to none in the state. The affair was a great surprise to Mr. Ross, who, with President L. W. Shurtliff just returned from Chicago, where they signed the contract for the new \$45,000 organ for the tabernacle with the Kimball Organ Co. Miss Jeanette McKay in a short address expressed the kindly feeling felt by the choir members towards Mr. Ross and in behalf of the choir presented him with an elegant watch set with a diamond and suitably engraved.

Mr. Ross was overcome with emotion, and expressed his deep appreciation for the gift and President Shurtliff made a few appropriate remarks. The choir will immediately take up the preparation of some fine choruses to be rendered at a concert to be given in a few months for the purpose of raising the balance of \$1,500 needed to pay for the new organ in full when it is placed in the tabernacle, which will be some time in September or the early part of October.

SAD DEATH OF YOUNG MOTHER.

Mrs. Edward J. Watkins Succumbs to Blood Poisoning.

Ogden, June 1.—The angel of death has for the second time visited the home of Edward J. Watkins, 1140 Twenty-fourth street, each time taking from him his life companion. At a o'clock yesterday afternoon his young wife, Mrs. Watkins, passed peacefully from mortality, having given her life to become a mother. She gave birth two weeks ago to a lovely babe, but septemia set in, and for days she suffered agonizing pain, but bore her suffering bravely with an abiding faith in her Maker.

Mrs. Watkins was born at Lewiston, Cache county, 22 years ago, and was married less than two years ago to Mr. Watkins, who had previously had a wife, who was Miss Alice Blair, assay, leaving him with several children. The sympathy of the entire community goes out to Mr. Watkins in this his deep hour of sorrow. The time and place of funeral will be announced later.

HUNTSVILLE CORPORATION.

Nelson, Hall & Adams Incorporate for \$25,000.

Ogden, June 1.—Articles of incorporation of the Nelson, Hall & Adams company have been filed with the county clerk. The principal place of business of the company will be Huntsville, Weber county, and is incorporated for a period of 50 years. The business pursued of the corporation will be the carrying on in all its branches, livestock raising and the products thereof, to buy and sell all kinds of merchandise to operate a wholesale and retail mercantile business, to conduct and carry on a creamery, butter and cheese factory. The company is capitalized for \$25,000 divided into shares of the par value of \$1 each. They own considerable land in Ogden valley. The officers of the company are Lars Nelson, president; George H. Hall, vice president; Herbert G. Adams, secretary and treasurer and they with John Hall, Daniel H. Felt and Mosiah Hall, form the directorate and are the incorporators.

MALICIOUS MISCHIEF.

ALUMNI DAY B. Y. UNIVERSITY.

Marked by Large and Enthusiastic Gathering—Eloquent Address.

Provo, June 1.—Alumni day at the Brigham Young University is always a most interesting occasion, and yesterday was fully up to the standard. The attendance was far greater than last year.

The presence, here and there, among the alumni, of gray hairs and other signs of the passing of years, reminds one that the experimental stage of the university is past, that it is no longer a new and untitled institution. This fact is strongly emphasized by the splendid buildings and appointments of the university when compared with those of the "seventies" and which some of the older alumni told one another about.

Seated on the platform were the following officers of the association: President Stephen L. Chipman, Secy. E. H. Holt, Corresponding Secy. Annie L. Gillespie, and Treasurer Calvin L. Hinkley.

President Hinkley delivered the address, which was a most eloquent and inspiring one. He spoke of the growth of the Brigham Young university and the alumni association of that institution. There are at present, he said, 2,000 members of the association, and today will be added 52 new members, graduates of the present year.

Reference was made to a crisis in the history of the university. There are those, said the speaker, who would reduce the institution to an institution of secondary education only—to do nothing more than high school work.

When an engineer plans the building of a road, continued Prof. Hinkley, he must consider two points, the place of beginning, and the end. The road of this institution has been planned to ascend to great heights. These plans must be carried out.

Prof. Hinkley appealed to his hearers to come to the support of the institution, to actively assist in its progress and advancement. The work must not be left alone to the board and the faculty of the institution. The help of the alumni is needed. Let us stand, the speaker said, individually and collectively for the development of this great school. He would not disparage the work of any other school of the state; let them go on and perform their work. But the Brigham Young university is needed to give to the young people good citizenship, manhood, and force of character. It had been argued, Prof. Hinkley said, that this institution could not expect to become a great institution as it did not have the support of the state; but, said he, it has the support of the church of Jesus Christ of Latter-day Saints, and to us "belongs the earth and the fulness thereof," if we can get it.

The speaker then outlined more definitely the help that was needed by this institution. The enrollment of the institution should be increased to 2,000, and more buildings should be erected, and as a place for additional building, the magnificence of the site on the brow of the hill occupied at present by the campus, was eloquently portrayed. The speaker further urged that the graduates of the institution should stand on a par with those of the state

University in regard to receiving state certificates and diplomas. In conclusion Prof. Hinkley suggested that in the business meeting a resolution should be presented, providing that President Brigham should preside over the institution for 25 years after the enrollment had reached the 2,000 mark.

The address of Prof. Hinkley seemed to meet with the hearty accord of his auditors.

Miss Miriam Nelke very delightfully presented an English-French love scene from "Henry V."

T. H. Grace, in a well chosen remarks, represented Utah county.

A vocal selection was nicely rendered by Mr. Reese.

President G. H. Brimhall responded to the sentiment, "Our Alma Mater." Reference was made to the various schools of the university and the work being done by them. The graduating class received warm praise. In referring to the commercial college graduates, President Brimhall expressed the opinion that there was sufficient demand ability in the class if banded together to keep the school running for the next five years.

In speaking of the institution, President Brimhall said: "There are no stains on our banner. There are no dark spots in our history except of sorrow. What we have gained has been gained honorably, and not at the expense of any sister institution."

A selection was given by the B. Y. U. orchestra, a meditation by President Joseph E. Keeler.

OFFICERS ELECTED.

At the business meeting of the alumni, officers for the ensuing year were elected as follows:

President, J. William Knight; first vice president, Ira N. Hinkley; second vice president, Leah Dunford Widmore; secretary, E. H. Holt; corresponding secretary, Fred G. Warnick; treasurer, John T. Reese; members of executive committee, the president and vice presidents; Heber Jex and Mrs. Mary Smoot Glazier.

THE BANQUET.

The banquet was the most elaborate ever given in the history of the association, and was thoroughly appreciated by the alumni.

As toastmaster, W. E. Rydahl acquitted himself most happily. The past, the present, and the future of the institution, were the three principal topics, and were responded to by Messrs. S. D. Moore, T. N. Taylor, and John Nottal, the first two in a humorous vein, and the last in enthusiastic earnestness.

Other toasts and sentiments, mostly in lighter vein, made the banquet a highly enjoyable affair.

The alumni ball in the evening was well attended, and was a complete social success.

UNDERWRITERS DEFINE POSITION

Regarding Adjustment of Liabilities in the San Francisco Conflagration.

WON'T PAY QUAKE LOSSES.

Rules as to Others Seemingly Fair—No Attempt to Evade Liability.

New York, June 1.—An important meeting of American insurance companies was held yesterday when resolutions setting forth the position of the underwriters represented as regards the adjustment of liabilities in the San Francisco conflagration were unanimously adopted. The rules adopted affect, it is claimed, not less than 75 per cent of the insurance carried by American corporations and explicitly deny liability for purely earthquake losses.

After pointing out the complex and intricate nature of the problems presented for solution and stating that it is highly desirable that all losses for which the companies are legally liable should be promptly and fairly settled, the resolutions continue: "Whereas, It is expedient that a statement as to the legal and moral liability of the companies in regard to the claims arising from the catastrophe at San Francisco should be made, the subjoined are adopted as a fair statement of such liability, suitable to be used as the basis for adjusting losses:

"First—Where policies covered buildings (and or their contents), which had certainly fallen before the fire or which had been so damaged as to void the insurance under the express terms of the contract, claims under such policies should not be paid.

"Second—Where policies covered buildings (and or their contents), which may have been damaged or destroyed by the earthquake, civil and military, subsequent to the conflagration claims under such policies should not be paid until the facts have been definitely ascertained.

"Third—Where policies covered buildings (and or their contents), which were probably, but not certainly, so damaged by earthquake, as to be brought within the provisions of the fallen building clause; or

"Fourth—Where policies covered buildings (and or their contents), which had suffered from shock of earthquake, but to such an extent as to bring them within the provisions of the fallen buildings clause; or

"Where policies covered buildings (and or their contents) which had been damaged or destroyed by the earthquake, civil or military, before fire had reached them; or

"Where policies covered property whose owners by reason of the destruction of their books and records, are unable to supply the proofs of value required by the conditions of their insurance policies. In all such cases claims should be settled by a reasonable compromise.

"Fifth—Where policies covered contents of buildings which are certainly not affected by exceptional conditions of the policy claims under such policies should be paid as soon as adjusted subject to such deduction, if any, as may fairly be made on account of the salvage resulted from the removal of
