MEMORANDUMS IN REBELLION. Report of the Revenue Fined in the U. S. Court.

MILWAUKEE, Sept. 20.—The general report of the collector of the Northern Pacific railroad, showing the condition of the property, which was ordered by Judge Jackson, was filed in the United States court late this afternoon. The report is a voluminous document, containing nearly forty pages of printed sheets, together with the original balance sheets and records from the collector's office.

The report deals largely in generalities, as it would be impossible, the receiver says, to present a detailed history of the administration in so brief a space. Tables are attached, however, to show that in the last year of the receiver's administration the operating expenses have been decreased. The troubles of the receiver's office are pointed out. The receiver says further that the condition of the road is not such as to enable it to compete on an equal basis with its rivals, and that to remedy this will require the expenditure of \$2,000,000 in the next five years.

Summed up, the report continues, provision should be made for the extraordinary expenditures in the next five years of \$2,000,000, that the property may be passed on an equal footing with its rivals for acquisition.
