SHEEPMEN IN CONFERENCE.

DEATH OF NATHAN SMITH.

Pioneer and Veteran of 73 Years Down Life's Burdens.

 Smithfield, Cache Co., Jan. 27.—Last Saturday afternoon the funeral of Nathan Smith of Oxford, Idaho, was held in the First ward meetinghouse. Consoling remarks were made by Bishop Hatch of Oxford and Elders E. E. Miles, Sr., and Samuel Nelson. The funeral was well attended by relatives and friends. He was born in Lancashire, England, 25 years ago. He came to Utah in the fifties and resided for several years in Union Fort. He came to Smithfield in 1861, where he resided for a time but later moved into southern Idaho, where he resided until last December when he came to Smithfield, sick, and died of pneumonia last Wednesday evening. He is survived by two brothers and one sister, Mrs. Alice Doms, with whom he was living at the time of his death. Also 10 children, many grandchildren and a host of friends.

DEATH OF NOBLE PIONEER.

Mrs. Collins R. Hakes Closes Honored Career After Long Illness.

 Mesa, Maricopa Co., Ariz., Jan. 25.—Mrs. Mabel Ann Morse Hakes, wife of President Collins R. Hakes, died Jan. 25, after an illness lasting over two years. Mrs. Hakes was born in MacDonough county, Illinois, April 18, 1836, daughter of Justin and Elizabeth Town Morse, who were early converts to the Church of Jesus Christ of Latter-day Saints. Mrs. Hakes was over a devoted member of the church, and had a vivid recollection of the Prophecy of Joseph Smith, and events connected with the expulsion from Illinois and the journey across the plains. She resided in Salt Lake valley in the spring of 1860, then a child but to years of age. In 1861, when her father was laboring and traveling, she was taken to the home in the beautiful San Bernardino and crossed the desert back to Salt Lake, and while traveling on the Santa Clara river her first child was born.

They reached Farmington, Iron county, on the 24th of December, 1861, and remained until the 24th of the following April, when they started for Salt Lake City to assist the poor in their removal from that city at the time of the "move." In 1862 they went to Kanab, Millard county, and lived there for two years. In 1864 she was chosen counselor to President Adelia Kimball in the Relief society and from that day until her death her heart and hands were with the great relief work. In 1865 they moved to the non-kingdom land of Arizona, settling at Mesa. Here she was selected as a counselor to President E. G. Macdonald of the Relief society. In 1867 she was chosen president of the Mesa ward Relief society, and still later stake president of the society. She was a great blessing to all, particularly to my son and myself.
