AN OATH-BOUND INNER CIRCLE

Said to Exist in Western Federation
of Mines.

PLEGGED TO OBEY ORDERS.

So Charges Denver Citizens' Alliance
—Wants Unlawful Carriers of
Deadly Weapons Arrested.

Denver, Colo., Aug. 3.—At the meeting of the Citizens' alliance called for the purpose of indorsing the actions of the Citizens' Protective league of Idaho Springs, Colo., in expelling from that city 14 members of the local miners' union the day after the blowing up with dynamite of the converter house of the Sun and Moon mine—recently, resolutions were adopted compelling the course of the alliance of Idaho Springs and the law officers of Clear Creek county, "which, while involving a technical deviation from the letter of the law, became nevertheless necessary, owing to the exigencies of the case." The preamble of the resolutions charges that within the organization of the Western Federation of Mines "there exists a strict, oath-bound inner circle pledged to commit personal violence, murder and destruction of property at the behest and mandate of their leaders, who, in turn, are a law unto themselves and recognize no rights of others and by unlawful means seek to control some of the most important interests of the state."

The resolutions conclude with an appeal to those in authority to arrest and prosecute all persons who unlawfully carry deadly weapons concealed about their persons.

The meeting was held behind closed doors, admission being by card and the representatives of the press were excluded. It was stated, however, by officials of the alliance that something over 700 were in attendance.

Faulkner's Trial Held.

St. Louis, Aug. 3.—The trial of former Delegate Harry Faulkner indicted and once convicted on the charge of perjury in connection with the suburban boodle deal, began today in the circuit court, before Judge Douglas. Faulkner was convicted and sentenced to two years' imprisonment on his first trial but the supreme court reversed and remanded the case. The second trial last week ended in a hung jury.

Presbyterian Ordinances Failing Off.

Paterson, N. J., Aug. 3.—The Rev. Dr. W. H. Roberts, stated clerk of the general assembly, has issued the figures of the Presbyterian church for 1903. The most striking feature is the falling off in the number of ordinations. The number was 290 in 1898, but there were only 184 this year, or 52 fewer than the ordinations for 1902. The total membership, however, shows a steady growth. It was 975,877 in 1898 and at present is 1,067,477. In finances a steady growth is shown. For home missions the amount given last year was \$1,291,321, the largest in the history of the denomination. The amount for foreign missions nearly equaled the record and was \$1,000,000. The total general assembly cost \$34,405.

Davenport, Ia., Aug. 3.—Agnes Roddion, 10 years old; Lily Roddion, 13, and Otto Roddion, 19 years, old, of Moline, and David Roddion, 19, of Chicago, were drowned in the Mississippi river tonight while boat-riding.

Mrs. McKinley's Uncle Dead.

Canton, Ohio, Aug. 3.—Joseph Saxton, aged 72 years the last surviving uncle of Mrs. McKinley, died today of cerebral anemia.

CARRIE NATION'S CHAMPION.

Wealthy Coal Operator Brings Suit
To Recover Damages for Her.

Seranton, Pa., Aug. 3.—William Law, a wealthy coal operator, today engaged attorneys O'Brien and Martin, and W. H. Jessup and W. W. Johnston to bring action against Mayor Connel and the city of Scranton to give him interference with Carrie Nation's arrest. He says his action is not personal, but is solely actuated by motives of the public good. He wants the courts to define the right of free speech.

MISSOURI BOODLING.

Special Grand Jury Impelled to
Investigate Matter.

Jefferson City, Mo., Aug. 3.—A special grand jury to inquire into legislative boodling was impaneled today by Judge Hazell. In the course of his charge to the jury Judge Hazell said: "The impression widely prevails in this state that dishonesty was practiced in certain measures pending before the legislature, that 'boodling' was indulged in; that 'hold-ups' were committed."

Spoon Cake.

Beat the yolks of five eggs until light and thick with an egg beater, add one cupful of sugar, gradually beating all the time, then add the grated rind and juice of half a lemon. Beat the whites stiff, and fold in one-half of these into the yolk and sugar, then one-half cup of flour which has been sifted five times, fold in the remaining whites, then the balance of the flour. Bake in an unbuttered pan.

New England Huckleberry Cake.

Two heaping tablespoonfuls of butter creamed with one cup of sugar, cream into the yolks of two eggs, add to this one and a half cupfuls of sweet flour, measured after sifting, with three level teaspoonfuls of baking powder, well and add one and a half cupfuls of huckleberries which have been well floured, and lastly fold in the stiffly beaten whites of the eggs. Bake in a moderate oven 45 minutes.

Spoon Cake.

Beat the yolks of five eggs until light and thick with an egg beater, add one cupful of sugar, gradually beating all the time, then add the grated rind and juice of half a lemon.
