J. A. Bennett tendered his resignation this afternoon as commissioner of pensions. It was at once accepted, and W. W. Dudley, United States Marshal of Indiana, appointed to succeed him.

Judge N. C. McFarland, of Kansas, was appointed by the President, this afternoon, commissioner of the general land office, vacated by the resignation of General Williamson.

The attorney-general declines there is no law making preliminary examination conditions precedent to provision in the marine code.

It is not thought probable from intimations obtained at the treasury department, based on present indications, that there will be any recommendation to refund legislation. It is the opinion of those high in authority that the refunding of high rate bonds under the present system into bonds of a low rate of interest, is far more advantageous to business interests than the agitation of the question by the treasury.

The secretary of the interior, to-day, denied the pending request for a day of issuance of a patent and a rehearing of controversy concerning the public lands of San Jose. He officially informs the commissioner of mineral land of Wyoming, that he has carefully examined the decision and order made by the land office and by his predecessor, Secretary Schurz, in this case, and finds no reason to disturb the issuance of a patent in conformity with the amended survey of Deputy Surveyor Thompson. The application for rehearing was for the purpose of excluding from the public lands a triangular tract known as "Willow Grove," now owned by the old Feltwell Bank, of San Francisco, under foreclosure of a mortgage made to secure a large loan upon it.

Inquiry in official quarters concerning the appointment of Henry Cope, as agent at San Francisco, vice Payne, removed, elicits the information that there are no charges against Payne's official conduct, and it is held there was no sufficient reason for his appointment, for the first place, and Cope is regarded as a man of suitable character.

The treasury department, to-day, purchased 345,000 ounces of fine silver for the Philadelphia and San Francisco mints.

It is not thought probable from intimations obtained at the treasury department, based on present indications, that there will be any recommendation to refund legislation. It is the opinion of those high in authority that the refunding of high rate bonds under the present system into bonds of a low rate of interest, is far more advantageous to business interests than the agitation of the question by the treasury.

The secretary of the interior, to-day, denied the pending request for a day of issuance of a patent and a rehearing of controversy concerning the public lands of San Jose. He officially informs the commissioner of mineral land of Wyoming, that he has carefully examined the decision and order made by the land office and by his predecessor, Secretary Schurz, in this case, and finds no reason to disturb the issuance of a patent in conformity with the amended survey of Deputy Surveyor Thompson. The application for rehearing was for the purpose of excluding from the public lands a triangular tract known as "Willow Grove," now owned by the old Feltwell Bank, of San Francisco, under foreclosure of a mortgage made to secure a large loan upon it.

Inquiry in official quarters concerning the appointment of Henry Cope, as agent at San Francisco, vice Payne, removed, elicits the information that there are no charges against Payne's official conduct, and it is held there was no sufficient reason for his appointment, for the first place, and Cope is regarded as a man of suitable character.

The treasury department, to-day, purchased 345,000 ounces of fine silver for the Philadelphia and San Francisco mints.

Secretary Lincoln referred to General Sherman the letter from Secretary Kirkwood, relative to the alleged establishment on the South side of the river, of a new mint, by the Denver and Rio Grande railroad, and the erection of saloons, dance houses, etc., with the request that the General see to it that proper action towards removing the intruders.

The following named gentlemen of the signal corps, are members of the Lady Franklin Bay expedition, soon to start for St. John: Sergeant Edward Israel, D. C. Ralston, and H. S. Gardner.

Commissioner of pensions, Bentley, in resigning, takes that occasion to write a letter, showing the great improvement of the service and the great credit given to his administration of the office. He wishes the administration and his successor complete success.

The President's request for the resignation of John C. McFarland, of Kansas, to be a reflection on his personal or official integrity, but based on complaints of his management and reorganization.

The President offered John a foreign appointment, and he declined.

Evening papers say that Pittney, custodian of the treasury, will retire at the close of the fiscal year and General F. W. Whitaker, of this city, will succeed him. He was Chief of staff during the war, and is a prominent republican member of the Tow Path Club.

WASHINGTON NOTES.

WASHINGTON, 16.—The President has decided to appoint John C. McFarland, of Kansas, commissioner of the land office; Marshall Dudley, of Indiana, commissioner of pensions; and Benjamin H. Brewster, of New York, to resign this afternoon. Dudley may be transferred to the patent bureau next fall at his own request, and Commissioner McBride be named assistant secretary of the interior.

Gen. Longstreet called on the President to-day. He will be United States Marshal of Georgia after July 1st. He has not thought of the Malone plan for dividing Georgia democrats, but is willing to do all possible for the republican party.

Secretary Windom telegraphically denied the story telegraphed hence that he refused to publish the report of the treasury committee on the Sherman bill. The report was not published. The story about Sherman originated with a Pittsburg man, who called on him, and he said he would not publish the report of the committee.

J. A. Bennett tendered his resignation this afternoon as commissioner of pensions. It was at once accepted, and W. W. Dudley, United States Marshal of Indiana, appointed to succeed him.
