The rioters arrested last night, for shooting at a police officer, were shot through the lungs, McCouville, with his eighteen men, was in advance and in a position of much danger, the Indians being concealed in the timber on either

side of them. McCouville soon saw the regulars firing. The Indian shots, through their tactics, drew the attention of the regulars, as to let McCouville and his men out of the trap, and seeing that the whole force of regulars had taken to flight, he found it necessary to follow them rather than suffer his handful of men to be cut off. The whole party, however, returned to Camden, leaving Joseph's men masters of the situation. All the command had recrossed to the south side of Clearwater, and were to move to Lapwai, where, with artillery, are to hold the position until Colonel Green's force from Boise joins them. Howard is to return to Lapwai and Hunter is to move north to the Spokane country. The volunteers will soon leave the field and return to their place and be disbanded. It is thought that no one can foretell whether or not the war is ended. Many of the Indians who have surrendered are reservation Indians and acknowledge that they fought with Joseph. They are to be brought to Lapwai for trial. No one seems to know for what plot Joseph will make next.

At 11:05 a.m.—A dispatch is just received stating that Joseph's warriors had recrossed Clearwater and were at Lawyer's cañon. Gen. Howard is at Lapwai. He has ordered the troops arriving on the same day to proceed forthwith to said point. He has also ordered for General Sully to meet him at Lapwai at 7 o'clock a.m. There is a great demand for wagons to take infantry to the front.

The Governor's Investigation.

A Portland press dispatch says, prior to the adjournment of the Grover commission, Senator Salisbury stated that Grover did not desire to put himself on the stand, but if any member of the commission desired to ask him any questions touching the matter under consideration, he was willing to answer honestly. No desire being expressed to examine Grover, he was not put on the stand.

The Daily Oregonian, the leading independent paper, in summing up the case, editorially says, the verdict is not proven. Looking over the whole ground, it may be said there is a probability that money helped to secure the result, but money was not the leading influence. Grover's success was owing largely to many being persuaded that he was honest, but if he was rejected, this was the rallying cry, and the pressure of the pending election for President was the main condition that made his success at all probable. Even within his own party he is very unpopular. The last time he ran for governor he received but 9,713 votes, a number much less than was thrown for him when he was first elected to office, and nearly 5,000 below what Tilden received.

THE RAILROAD RIOTERS.

BALTIMORE, 21.—At this hour, 1:45 a.m., it is ascertained positively that ten were killed. Ten of the rioters who were arrested by the officers of the police and police officers, said that several who were seriously shot were taken to their homes.

2:30 a.m.—The Governor has issued the following:

PROCLAMATION.

Whereas, the riotous demonstrations that took place in this city, last evening, evince a spirit of lawlessness, which, if not suppressed, must end in the ruin of vast interests, and the destruction of a large amount of property of our citizens.

Now, therefore, I, John Lee Carroll, Governor of Maryland, hereby issue this proclamation, calling upon all law-abiding citizens of Baltimore, to aid in the maintenance of quiet, and I hereby command all persons to abstain from the purpose of violation of law, but to retire forthwith to their peaceful, respective homes, warning them that persistence in these violent proceedings will compel a resort to the most drastic measures for the re-establishment of order in our midst.

(Signed) JOHN LEE CARROLL, Governor.

During the fire at the Camden station, last night, Governor Carroll sent a dispatch to President Hayes, stating that the day had been fired by a mob beyond control of his forces, and asking that assistance might be afforded by the United States authorities. This morning, a dispatch from Governor Barry, commanding at Fort McHenry, was received through the signal office, by Gov. Carroll, from the Secretary of War, in answer to his application to the President for troops, which read as follows:

"The Secretary of War directs you (Gov. Barry) to report to the Governor of Maryland, with guns, and all of your men, to act according to the order."

The message was sent, as received, to Fort McHenry, by a mounted orderly, who returned with word that the troops are in readiness at a moment's notice.

The firing at the Lill Street portion of the Baltimore and Ohio Railroad Depot was caused by the mob attempting to interfere with the train. The mob, however, was put out of the fire of the engine, and fired upon the police, who returned the fire and drove the mob back
