WASHINGTON NOTES.

Samuel J. Randall Shows Signs of
Improvement.

WASHINGTON, July 11.—Many of
Samuel J. Randall's colleagues in
Congress made flying trips today over
to his home which is only a few blocks
distant from the capitol to inquire
into his condition, while the papers were
sent to and from by other members who
could not go personally. When the oc-
casion called for his presence, he was
seen to the doorway and gave the neces-
sary information to the callers. He
appeared to be more cheerful than
yesterday and showed a confident be-
lief that he would recover from the
attack. He raised his head during
the morning and has taken and appar-
ently assimilated liquid nourishment.
It is the expectation of the family,
however, that Randall will be able to
resume the discharge of his duties in
Congress during the remainder of the
session, the intention being to remove
him to the House by Belmont
station, as soon as his
condition justifies the removal.

Dr. Lincoln called on Randall this
evening and found him bright and
cheerful and in better condition gen-
erally than earlier in the day. He has
begun to show signs of returning
strength. Early this morning he had a
slight chill followed by a fever but this
has passed off.

THE GREAT FLOODS IN MEXICO.

ST. LOUIS, July 11.—Late advices
from Leon, Mexico, the principal scene
of the great flood, says: Masses of the
people are packed in the portals of
shelter, awaiting every available place
of refuge, averaging one person to less
than a square yard of space, with
flooded districts on the ground for beds
and a few miserable rats for cover.

THE MONSIEUR FLOOD.

PITTSBURGH, July 11.—The latest
estimate of the damage put the total
loss at over one million dollars.

WHEELING reports the damage in the
