The National Irrigation Congress Now Adjourned.

SIXTH MEETING AT LINCOLN, NEB.

The officers elected—Resolutions adopted—An exceptionally successful Convention.

PHOENIX, Ariz., Dec. 17.—The fifth session of the national irrigation congress opened and for the fifth time the irrigators of the nation have met to discuss their common interests.

The session has been the most businesslike known to the body and the organization will now be on a basis of a regular organization with special committees and with funds for pushing irrigation.

PRICE FIXING ILLEGAL.

San Francisco, Cal., Dec. 17.—The fight between Sharkey and Fitzsimmons for the possession of the \$10,000 prize was concluded today, when Judge Henderson of the superior court decided the judgment restraining the Anglo-California bank from issuing the check.

Continued for Sharkey called the attention of the court to the state law forbidding prize-fighting, between which there was no difference, and he thereupon decided that a case involving the possession of a purse for prize-fighting was not standing in court.

The judge concluded in the case that the prize money had terminated the proceedings and that the prize money was to be paid to the victor.

At 4:15 p. m. the judge has a brief recess and adjourned till Monday.
