THE SENATE.

WASHINGTON, Jan. 11.—In the Senate, Culkin reported favorably from the committee on commerce the Senate bill granting autonomy to the District of Columbia, and giving the right to construct a dam and power station in the Mississippi river at Bismarck, N. D. The bill was amended by requiring that the work begin within two years and be completed within four.

On an amendment by Hawley, Conn., the bill went over.

The Committee Against Standard.

Mr. LONG, Jan. 11.—Twenty-six senators of the Chamber nation voted and unanimously against standard or the exclusive right of the railroads. The same feeling exists in the other four railroad cities, it is said, and the advance of the government will undoubtedly be reversed.

The Burlington Train Robbery.

Republican Leaders in Council.

WASHINGTON, Jan. 11.—The Republican national executive committee met yesterday afternoon to consider principal questions to be considered in the future of business and the establishment of economic bases. Republican politicians of all degrees gathered in the parlor of the Arlington hotel and the session was divided on the question whether to remain in the campaign or to seek a new base. The choice for headquarters is divided between New York, Washington and Chicago.

Chairman Thomas H. Carter resigned the chairmanship on account of business. Joseph H. Manley, of Maine, was chosen temporary chairman of the executive committee and Carter was appointed to the permanent committee. Stanley was empowered to open negotiations and New York was practically chosen as the place.

All Gates at Home.

WASHINGTON, Jan. 11.—A forty dollar fine was imposed at the Manchurian legation which arrived by the Washington, D. C., Vancouver, B. C., Victoria, and Seattle. The fine is to go to the Chinese government.
