DESPERATE SHOOTING.—In the first number of *The Sweetwater Mines*, published at Bridger on its way to that mining region, we see the account of a desperate shooting case, at the settlement on Henry's Fork, a few miles east of Bridger, on the 29th ult., between a Mexican and an Englishman, in which the former shot the latter twice, the first ball striking in the breast and throwing the man around, and the next striking him in the right side, passing through his chest and lodging in his left arm, bringing him to the ground. While on the ground, in a dying condition, the Englishman steadied his revolver with both hands and fired, hitting the Mexican in the abdomen, inflicting a mortal wound, and bringing him to the ground. Satisfied with this performance the Englishman died, and the Mexican crawling up to him fired two more shots into his body, then rolled over and was a corpse. In five minutes from the time the fight commenced both were dead.
