tural steel in this country, including the American Bridge company, one of the constituent members of the United States steel corporation, have combined together to fix prices and to restrain by means of exclusive bids and false representations, their conduct is not only repugnant to common honesty, but is plainly obnoxious to the federal statute known as the Sherman anti-trust law.

SHOULD MAKE AN EXAMPLE.

The commission believes that an example should be made of these men, and that the members of the Boston agreement or at least all those who in October and November, 1908, entered in the freightline compacts for the Cave street bridge, should be brought before a federal grand jury for violation of the act of Congress. It is the commission's desire, your limitation for participation in these transactions has not yet elapsed and the evidence obtained by the commission is so complete that there should be no difficulty in the government's securing a conviction in this case."

I have submitted this report to the department of justice for thorough investigation and for action if action shall prove practicable.
