LOCAL BRIEFS.

Broke Both Arms—John Davis, of 824 East Third Street, aged 14, fell from a poplar tree yesterday afternoon, and broke both his arms.

Really Transfer—H. Burnett of Colorado has bought three and one-half acres at Ninth East and Fourteenth South streets from H. C. Scott for \$2,600.

Daughter a Bankrupt—A petition in bankruptcy was yesterday filed in the federal court by Barney Daugherty, a Salt Lake teamster, who schedules liabilities at \$748.42 and assets \$320.

Future of Norway—Prof. Erling Bjornsen will lecture this evening on "The Future of Norway" in the fourteenth ward meetinghouse, where all Scandinavians in particular are invited.

Eight Lots Sold—A. Hanauer of this city has bought from the Seale Incorporated company yesterday afternoon, eight lots on Fifth West street near Sixth North for \$1,000, and Mr. Hanauer will erect eight cottages thereon.

Students Registered—Two hundred and eighty-eight students registered at the high school yesterday, which with 212 the day before, makes 600 for the two days. Today is the last day of registration. Classes will be made up Saturday, and on Monday school work will be started.

Given a Floater—J. J. Kelly, who was arrested a few days ago on suspicion of having been implicated with N. N. Norton in robbing a west side saloon, was yesterday given a floater out of town by Judge C. B. Diehl. It was impossible to connect Kelly with the holdup and a charge of vagrancy was lodged against him.

Meeting of Daughters—The spirit of liberty chapter, Daughters of the American Revolution, met yesterday afternoon, at the residence of Mrs. Geo. Y. Wallace. Mrs. Thomas Weir gave a recital of her trip up the Nile, and there were musical selections by Miss Esther Allen on the violin and Miss Judith Evans on the piano.

Dawson Gets 30 Days—A man named Ed Dawson was yesterday sent to jail for 30 days by Judge Diehl. He was charged with having stolen a bottle of beer from a saloon, and he begged the price of a drink from David Irish, and because the latter did not donate, Dawson struck him. He got by far the worst of the melee that followed and in addition will have to work on the city rock pile for a month.

Boys in Demand—The opening of school has greatly reduced the number of cash and store boys in the city, practically cut it in half, and one firm alone is calling for 20 bright boys at once. The wages earned by these boys varies from \$2.50 to \$5 per week. A shortage is also reported in the number of men dry goods clerks, as there are so many men going into the mining fields.

Cullen Hotel Annex—The remodeling and repairing of the Cullen hotel has begun. The improvement will include a six story annex at the rear of the present building, 28x17 feet, and in the rear of that will be a two story servants' dormitory, 28x17 feet. The entire hotel will have 200 rooms and the latest conveniences including telephones. The entire cost of the work may run up to \$150,000.

Violated Injunction—A writ of citation has been issued from the United States district court against Isaac and Milton Kahn, requiring them to appear before Judge John A. Marshall to answer for disregarding an injunction of the federal court issued July 7, 1906. The Kahns are railroad ticket brokers and are among the men restrained from dealing in what are termed "scalper" tickets. It is alleged that the Kahns disregarded the orders of the court, and they will appear next Monday to show cause why they should not be punished for contempt of court.

Car Line Improvements—The committee on streets of the city council received last evening, notification from the Utah Light & Railway company of its wish to lay on Third and Sixth streets the heavy rails being removed from east Second South street where heavier steel is to be laid on account of the asphalt paving. But the company desires to know what the prospects are for changes of grade on the bench streets, that the new track may be made on permanent lines. The city engineer will decide on the Third street grade without delay so that the company may know just what to do.

STOCKHOLDERS' MEETINGS.

NORTH JORDAN IRRIGATION COMPANY.—Notice of Annual and Special Stockholders' Meetings.—Notice is hereby given that on the 8th day of October, 1906, at 11 o'clock a. m., at the Ward House, in Taylorsville, Salt Lake County, State of Utah, the annual meeting of the stockholders of the North Jordan Irrigation Company will be held; and notice is hereby further given that at the same time and place a meeting of the stockholders of the North Jordan Irrigation Company is hereby called and will be held for the purpose of considering the following amendments to the Articles of Association of this company, to-wit:

Article 2. Amended to read as follows: This association shall continue to exist for a period of fifty years from the date hereof.

Article 7. Amended to read as follows: The private property of the stockholders of this association shall not be liable for its corporate debts or obligations.

Article 8. Amended to read as follows: The officers of this association shall consist of five trustees, a secretary, a treasurer and two auditors.

Article 12. Amended to read as follows: Any officer may resign by filing a written resignation with the secretary of this association, and any officer may be removed for cause by a two-thirds vote of the stockholders present at any duly called meeting.

Article 13. Amended to read as follows: The trustees may fill vacancies in the board of trustees, and also in case of a vacancy in the offices of secretary and treasurer.

Article 15. Amended to read as follows: The board of trustees shall adopt such by-laws for the government of this association, as may be deemed necessary by them; provided, however, that no by-law shall be binding upon this association, without first having obtained the approval of a majority of the stockholders present at a regular annual or specially called meeting.

Article 18. Amended to read as follows: This agreement may be changed or amended in any or manner as provided for by law.

That Article No. 29 be added to said articles of incorporation as follows:

Whereas, heretofore at various times amendments to the articles of incorporation of this company have, at a regular meeting of the stockholders, called for that purpose, been amended, and the said amendments have not been filed in the office of the recorder, and no record of the same as provided by law, or if so filed, have been lost, and are not now on record; and
