RAY LAMPHERE **GUILTY OF AROON**

He Was Tried on Charge of Murdering Belle Gunness and Her Three Children.

SENTENCE IS INTERMEDIATE.

Two to Twenty-One Years in Prison. \$5,000 Fine, Disfranchised For Five Years.

Laporte, Ind., Nov. 26 .- Ray Lamphere, charged with the murder of Mrs. Belle Gunness and her three chilidren by setting fire to the Gunness home April 28, was this evening found guilty of arson by the jury, which had the case since 5:30 o'clock last evening. Within five minutes after the verdict was reported Judge Richter had sentenced the defendant to the state prison at Michigan City for an indeterminterm of from two to 21 years, fined him \$5,000, and disfranchised him for five

tonight that a motion for a new trial would be made, and, should it be refused, an appeal to the Indiana supreme court would follow The Indiana supreme court is two years behind in its work, and so this case could not be reached until after he had served the minimum time of his sentence. Mr. Worden declared the verdict to be ridiculous.

"If he was guilty at all," said the attorney, "he was guilty of murder. He should have been acquitted."

The motion for a new trial will be based on the court's instruction that the jury could find Lamphere guilty of

Should the case be carried to the supreme court and sent back for re-trial, Lamphere could not be tried on any charge in this particular case excepting arson, the crime of which he was convicted. However, in an event of that kind the state would elect to try him on one of the indictments, probably he Helgelein case.

Members of the jury are reticent in

discussing what occurred in the jury room, but enough has been learned to know that but for two members Lamphere would have been found guilty of murder or manslaughter, the verdict being a compromise. Several members of the jury, it is understood, held out long for murder in the first degree, with a life sentence. So far as could

be learned, none was for hanging.

Lamphere, in a statement tonight, said that he was confident that the adult body in the fire was that of Mrs. Gunness. He reiterated his innocence in the matter of setting fire to the house, though admitting that he was on the road and saw the fire that night. He also declared that he did not see Mrs. Gunness kill Helegein. "I have Mrs. Gunness kill Helegein. "I have no complaint to make about the ver-dict. Things looked pretty blue, but Tonight all the members of the jury made the following signed statement:

"We, the undersigned jurors, im-paneled and sworn in the case of the state of Indiana versus Ray Lamphere, hereby say that it was our judgment in the consideration of this case that the adult body found in the ruins of the fire was that of Belle Gunness, and that the case was decided by us on an entirely different proposition."
