WASHINGTON, 3.—The resolution
submitted by Butler on Friday,
calling on the Secretary of the Treasury
for copies of all papers, etc., of
interest in his Department, relating
to the claim of the United States
against the New York Central &
Hudson River Railroad for a 5 per
cent tax on scrip dividend of 80 per
cent, declared in 1879, on its stock
capital, and that the Commissioner
action thereon until instructed by
Congress as to the manner of its
settlement, was adopted.
The Senate bill to consummate
the resolution of the Continental
Congress, by appropriating \$1,000 to
erect a monument to General Herkimer
at the battle-field of Oriskany,
New York, was passed.
Clark, of Iowa, said at the proper
time he would move to except the
credentials spoken of from the
five-minute limitation and
pledge the entire Iowa delegation to
support it. (Applause.)
Sharpe, of New York, said his
minority report was now ready, and
it was signed by the representatives
of nine States, whose votes were
necessary to the success of the re-
publican party. In the coming con-
vention, he said, he would not
postpone the enforcement of the five-
minute rule until the composition of
the Convention was decided. If that
agreement was not unanimous,
it had been at all events reached
without a dissenting voice. He
then moved to amend the motion by
deleting the phrase "on creden-
tials."
