

MICROSCOPICAL MEETING.

Interesting Session Held by the Members of the Society Last Night.

There was a large attendance at the regular monthly meeting of the Microscopical Society of Utah last evening, December 13, over thirty members and visitors being present. Mr. Neal read a paper on The Microscopic in Mineralogy and Geology which was highly enjoyed by the meeting. Microscopy of the Nervous System was treated by Dr. Boers with drawings of brain tissue, showing the arrangement of the body, which greatly resembled the great Atlantic cable in its structure. He was followed by Dr. Talmage in a lecture on Typhoid and the Germ Theory of Disease. Hand-drawn illustrations were presented showing the various structures of the body, and the use of Tyndall to prove the fact of the spontaneous origin of the theory is generally believed, by learned men. The meeting's business was closed with a report on the meeting held at a late hour, the meeting adjourned for one month.
