SWANNING AND WINTERWARMING.

No. Profitable Plan For Preventing the Frost, and the Like Need Not Invent.

There is no consumption so detrimental to the comfort of backwoods as that of the prevention of swarming. If this could be accomplished, the speakers could have several out spares and manage them by simply visiting them once a week during the haying season.

As it now is, there must be one to watch for and have scars, or the loss in this direction will be great. To raise and tend to the best advantage, it would be most feasible to plant a few trees at home and when they grow, in this condition swarming is quite likely to occur, and at present there seems to be no infallible practical, profitable method of preventing this loss. It is possible that one may yet be discovered. The best probably that can be done is to allow a generous entrance, shade the hive and see that there is an abundance of room to the surplus apartment.

To my mind, the place to remark upon is the best way to allay the fear of the swarming during the swarming season—power to have a few more scars from each colony, as with a few scars, they may get more honey in the fall, but more scars from a colony is not desired when long in the object sought. Fortunately afterswarming is preventable. The plan proposed now is called the Holden method and consists in laying the swarm upon the old hive and placing the old hive to the side, but with its entrance turned to the rear, so that the temperature day the entrance of the old hive is 45 degrees. Each day the entrance of the old hive is slightly toward the result that the new brood swarms.

At the end of a week both hives are sitting side by side, and if either were removed all of the flying bees would enter the eye that remained.
