S. postal agency at Yokohama, Japan, which agency at present exchanges mails only with the Hong Kong post office, by means of the U. S. mail packet, under the provisions of the U. S. and Hong Kong postal convention, and the Colonial government of Hong Kong having made arrangements for exchanging mails with the Hong Kong post office, the continuation of the agency at Yokohama, in place will not be necessary after January next. The agency has been under the charge of the U. S. consul at Yokohama, to whom no additional salary has been paid for the service, but he has been allowed about \$3,000 per annum for his office, the use of which will be saved to the government by this discontinuance.
