"Can any good thing come out of Nazareth," is a saying that applies to a large class, as to the views entertained of the "Mormons" by those who compose it.

APPLICATION FOR NATURALIZATION RE-FUSED. STRANGE PROCEEDING .- The following statement of a conversation which took place yesterday morning, between Chief Justice McKean and an applicant for the rights of naturalization, in the District Court of the Third Judicial District, is reported to us by Mr. William Horsley, the alien in question. question is concerned. Judge McKean: Then I refuse to naturalize you!
