

MINING, BUSINESS AND STOCKS

MAY DAY ACTIVE AT GOOD FIGURES

Stock Weathers the Gale and Sells
Freely at 25 Cents a Share.

WEEK'S BUSINESS ON 'CHANGE.

Shares Sold Amounted to 155,654, for
Which Buyers Paid the Net Sum
Of \$39,400.

Despite repeated attempts to bear
May Day, the stock weathered the gale
and on 'change today came out victori-
ous by selling at 25. True, there
were offerings below this, but they
were few and far between and not such
as to bode ill for the stock. New
York, which for some time past has
been a running mate, showed a slight
weakness and had its best bid at 21
with offerings at 22%.

The call developed a fair degree of
activity in Wabash, which sold at 61
and 62, while Daily-Judge came forward
at \$5.20, and Daily-West at \$12.75, seller
30. For Daily there was paid the sum
of \$2.65, and Sacramento did business
at 10 and 10%.

The week's business in the pit
amounted to 155,654 shares, which
brought the sum of \$39,400.75. While
trading was not at any time over-
active, the market held up well under
pressure and closed with an array of
figures quite promising.
