THE POPE'S ENCYCLICAL.

140 Invites Eastern Dissenting Churches to Meet at Rome.

He Extends His Hands to the East and Declares for a General Conciliarism.

Rome, June 10.—The pope's jubilee encyclical letter is completed and is now in the hands of the printer. It is a vast and important document from the point of view of a political treatise.

Every phrase of it has been carefully considered.

In consequence of favorable news from the eastern countries, the pope is about to call a conference in Rome of representatives of the dissenting churches.

At present, the new Russian minister to the Vatican, today communicated to the pope an expression of the czar's enthusiasm in receiving relations with the Vatican, which his majesty regards as leading to future peace.

The pope made a complete survey of the situation.

His majesty today gave an audience to General Tschirsky of the French army, and in the course of the interview made a strong pronouncement in favor of a general disarmament, which he declared was a duty to the end of procuring peace.
