"In any action brought under or arising out of the provisions of this ordinance, the fact that the party thereto represented himself or herself engaged in any busi ness or calling for the transaction of which alicense is hy city ordinance rethat such party exhibited a or sign indicating such business or calling, shall be conclusive evidence of the lia-bility of such party to pay for a license."

Committee on license.

CONDEMNED LAND.

Attorney Hall submitted the findings of the Third District court in the condemnation proceedings, Salt Lake City vs. James H. Taylor and Thomas E. Taylor, in which the court found \$1,335 for a portion of Third street taken and \$1,608 for the Second street extension, the amount to be paid within thirty days. Referred to the committee on public grounds.

WASHINGTON SQUARE DRAINAGE.

Engineers Doremus and Brooks re-ported that the Washington square could be drained to a depth of eleven feet by discharging the water into the ditch on Eighth South street or into the canal. As to the proper form of foundation on this site, they suggested that it should be such as would safely support the building under the present condition of the ground, independent of drainage. They did not think a drain was a sufficient guarantee that the original conditions might not be restored in the event of any obstruction in the drain. Their idea was to provide originally on the worst possible conditions at any cost rather than take the risks of greater ultimate costs. The matter was referred to the joint building committee and the committee on canals.

SCHOOL ELECTION JUDGES.
Attorney Hall reported that the school election in this district should be held on the second Monday in July next, and fifteen days before the elec-tion the Council should appoint from each precinct three judges of election. Notice of the time and place of holding the election should be given by the mayor for six consecutive days within ten days previous thereto. One trustee has to be elected from each precinct.

The report was adopted and the mayor appointed Councilmen Parsons, Anderson, Folland, Young and Kar rick to present names of persons to act as judges of the election. The committee reported the following names: First precinct, A. H. Parsons, William Fuller, Theodore Lovendale, Second precinct, J. P. Addleman, A. H. Kely, W. S. Burton; Third precinct, W. J. Beattie, H. Pembroke, George Lambourne; Fourth precinct, D. L. Murdock, A. Hanauer, R. S. Wells; Fifth precinct, J. F. Allen, J. R. Winder, Jr., C. B. Jack.
The nominations were confirmed.

SUNDAY AMUSEMENTS. The committee on license to whom was referred the petition of the managers of Wonderland asking permission to keep that place of amusement open on Sunday on condition that they maintain the best of order, etc., re-commended that the petition be grant-

The mayor suggested that there was an ordinance on this subject, and the report could not well be adopted without repealing or amending the ordinance.

Councilman Lynn said that the ornance would not prohibit the opening of the museum, and if the concerts were sacred concerts there was no ordinance prohibiting that. The report was referred to the committee on municinal laws.

JORDAN CANAL.

The committee on canals, to whom was referred the petition of B. F. Terry asking that the Jordan canal be repaired, recommended that the same be granted. Adopted.

TO SELL REFRESHMENTS.

Mayor Scott suggested that the Young Ladies' Aid society be given the exclusive privilege to sell the refreshments in Liberty Park this year. The suggestion was adopted.

MISCELLANEOUS.

The resignation of John Griffin as City Weightmaster and Poundkeeper was received and accepted. In his letter of resignation Mr. Griffin recomended W. P. Richards as his successor as did a petition signed by Alonzo Young and others. Adopted.

The report of the committee on streets in regard to the arrangements of the tracks of the Rio Grande Western on Sixth west street and other thoroughfares, and the conditions on which they were to be allowed to remain, was taken from the table and adopted,

The committee on streets reported an ordinance relative to sidewalk pavements, grades, etc., which was

adopted.

An ordinance prohibiting the throwing of dirt, rocks and rubbish into ditches was presented and laid over for one week.

An appropriation of \$2,000 was made to Mount & Griffin.

Adjourned for one week.
