

POWER TO DO GOOD UNRESTRAINED.

Address by ELDER GEORGE ALBERT SMITH, At the Seventy-Sixth Semi-Annual Conference of the Church of Jesus Christ of Latter-day Saints, in the Tabernacle, Salt Lake City, Saturday, October 7, 1903.

My brethren and sisters, I am grateful to my Heavenly Father this morning for the privilege of meeting with you in this house of worship. While I occupy this position I desire an interest in your faith and pray, that I may be inspired by the Holy Spirit to say such things as He would have me say unto you.
