FORTY-SIXTH CONGRESS.

CONGRESSIONAL.

SENATE.

WASHINGTON, 25.—Cameron, of Pennsylvania, introduced a joint resolution for the commission of three Representatives, three Senators and three citizens, to report on the regulation of interstate commerce.

The bill incorporating the National Education Association and the bill amending an act of 1879, authorizing the act of twenty-year five per cent. bonds of the District of Columbia, passed; also several private bills.

The Vice President presented a communication from the Secretary of War, with a letter from the Chief of Engineers, representing the importance of the appropriation of \$75,000 to defray the expenses of the geographical and topographical surveys of the Mississippi River.

Withers reported the sixty-sixth report of the Secretary of the Interior, placed on the calendar.

Adjourned till Monday.

HOUSE.

WASHINGTON, 25.—The question of reading the journals came up, and the Speaker said the still unfinished business was whether Wednesday's journal should be read before Monday's and Tuesday's.

P. Wood, as a compromise, suggested Monday, Tuesday and Wednesday Journals be read, and then the House voted on the resolution discharging the committee on the revision of laws from the consideration of the Townsend bill and refer it to the ways and means committee.

Blackburn and Townsend assented.

Townsend said those conscientiously in favor of this bill had been misled by the false issue which its opponents had raised. He admitted he might have spoken too firmly yesterday, but would not retract a single syllable.

After a long and heated debate between Kelley, Townsend and McMillen, Congress adjourned to Wednesday.

Townsend said he followed the precedents set by Kelley in introducing his bill without a definite title, and it might as properly go to the committee on revision of laws as to the ways and means committee.

Kelley said his feeling of confidence in, and warm regard for Townsend had changed to one of coolness and inquiry. He then went on to show that Townsend had violated a plain, unmistakable law in having this bill so referred. He stoutly defended the ways and means committee as a conscientious and hard working committee. He hoped that Townsend had committed would be the greatest mistake of his life.

McMillen complained that under the guise of a personal explanation Kelley was castigating a member.

Young thought the rules so imperfect and unintelligible they ought to be revised.

The previous question on McMillen's proposition was seconded, taking the bill from the committee on the revision of laws and referring it to the ways and means committee.

Blackburn demanded the division of the proposition.

On motion of Garfield, Monday's journal was then approved and Tuesday's journal read.

Tuesday's and Wednesday's journals were read and approved. After some discussion as to whether the McMillen resolution should be divided, the House, 142 to 109, discharged the committee on revision of laws from further consideration of the bill.

Thirty-five Democrats and greenbackers voted with the Republicans, and by a vote of 142 to 109 the bill was referred to the ways and means committee.

Converse, chairman of the committee on public lands, reported a bill to quiet titles to the Des Moines river lands in Iowa. Placed on the calendar. Adjourned.

WASHINGTON.

A Useful Debate.—The Chinese Question.—The U.S. Chief, Etc.

WASHINGTON, 25.—The deadlock in the House of Representatives over Garfield's motion, concerning the Townsend tariff bill, was terminated this afternoon by the adoption of the simple method of the approval of Monday's journal, and thereupon withdrawing the bill from the Townsend committee, and referring it to the committee on ways and means, a common sense procedure which apparently was not thought of until after the House had become too deeply involved in parliamentary difficulties and too much excited by personal controversies to act upon any sensible suggestion, while the excitement lasted. The whole struggle in fact has been a profligate of personal disputes and unparliamentary usages between members. The Speaker has been severely criticized for his rulings and had closed his eyes to all around him.

The nomination of the new minister to China and those of Commissioners Swift and Prescott were taken up during today's executive session of the Senate and referred to the committee on foreign relations, which will meet next Tuesday. It is understood that the commissioners are not to enter on their mission until Congress shall first have made an appropriation to defray their expenses. This, it is believed, will be readily granted. There seems to be little or no opposition to this nomination, and that of Mr. Angell as minister to Mexico is also expected to pass.

Representative Davis is assured by the ways and means committee that the bill will be taken up on the petition of J. Berli, and some 40 other cigar dealers of San Francisco, praying to be refunded taxes illegally collected from them.

Secretary Ramsey says: The government can only receive sitting Bull's people as prisoners of war, to be held until the government provides for their maintenance. Gen. Sherman regards them as British subjects.

The Secretary has bought 445,000 ounces of silver for the San Francisco and New Orleans mints. Secretary Thompson to-day ordered Porter, commander of the Constellation, to deliver her cargo to the Herd relief committee at Dublin, and explain that it was donated by a few generous hearted Americans, out of sympathy for the suffering Irish. He expresses satisfaction at the peaceful character of their mission.

A Saloon Blown Up.

COLUMBUS, 25.—The temperance people blew up a saloon in Berlin this morning. The building was completely wrecked. No names are known.

Whipping Post.

LOUISVILLE, 25.—The Senate has passed the House whipping post bill, which Senator Hayes denounced as a measure to punish negroes.

Death of a Friendly Indian.

SAN FRANCISCO, 25.—A Wallalla, Washington Territory dispatch says: Hawfish, Waquo, chief of the Cayuse Indians, died Friday last on Unadilla Reservation. The funeral was attended by over 1,000 persons, including many citizens of Unadilla County. He preserved the lives of all the white settlers in this valley early days, and his death is mourned by all who knew him.

Confidence Among Farmers.

Crop reports indicate that wheat throughout the State promises at least an average harvest, although more rain is needed. Since the date of these reports a general rain has visited the State and still prevails. Later dispatches show a feeling of increased confidence on the part of farmers.

Striking Tailors.

PITTSBURGH, Pa., 25.—The journey-men tailors of Pittsburgh and Allegheny City, numbering 500, struck today, for an advance, ranging from 10 to 15 per cent.

FOREIGN.

CREAT BRITAIN.

Foreign Notes.

LONDON, 25.—The Cologne Gazette reports that the man who in July last for speaking ill of the Emperor William was condemned to 18 months imprisonment, but has been liberated after serving six months of his sentence, owing to the discovery that two female witnesses on whose testimony he was convicted of the crime had committed perjury.

A Toronto dispatch says: A man named Bennett, formerly employed as engineer in the Globe newspaper office, but who was discharged for misconduct, entered the room of Hon. George Brown, at the office, and made a deliberate attempt to assassinate him. Without a word of warning he aimed a pistol at Brown's head, who was sitting at his desk. On hearing the intruder Brown arose, and as he did so received the bullet in his thigh. He at once grappled with the would-be murderer, wrested the pistol from him and threw him down. The employees of the establishment, hearing the noise, rushed to the assistance and held Bennett until a policeman arrived, who took him to the station. Brown is the editor and proprietor of the Globe, the leader of the reform party and Senator of the Dominion.

A Halifax special says: Owing to the demand on this province for coal for export to England, the price has advanced two dollars per 100 pounds.

Coal oil has been discovered in large quantities in the vicinity of Lake Anahy and Cape Breton.

Russia has forwarded 8,000 francs for the relief of refugees from Eastern Roumania.

The Paris Monitor says: If the intentions attributed to the cabinet regarding the Jews are not carried out, an interpellation will be addressed to the Government in the Senate immediately on re-opening the session, for the Senate would consider itself insulted by the conduct of the minister should they ignore the views it manifested on its vote on the Berry educational bill. France is five or six feet deep and trains are badly delayed in all directions.

The Chinese of Russia is somewhat weaker.

The Czar at a military parade was very friendly with Lord Dufferin, but cool toward General Chanzy, the French ambassador.

A dispatch from the Hague says: The Queen is delicate, important news in view of the failing health of the Prince of Orange.

Parrell and Biggs, home rule, have decided to run in Mayo.

One of the prisoners was recently sentenced at Castlebar Assizes to imprisonment for assaulting the process servers.

A St. John, N. B., dispatch says: The severest snow storm of the winter rages. It began yesterday. Snow is over a foot on the level. There are many huge drifts. Trains and steamers are delayed.

A ministerial crisis has occurred in Brazil. Saraiha has replaced Cassimiro, minister as president of the council.
