The plaintiff's claims, based by the Rogerses in the conduct of the business of the Grand Opera house, was that they have been much injured by the same. All the parties to the suit are or have been stockholders in the association, but in the process of "break-out" the plaintiff's claim is to have gained control and are therefore asking the court for relief. The case is one involving money which for a long time past have been public property and the outcome will be watched with interest.

Mr. Throckmorton, who commenced action against Robert Throckmorton to recover a decree of divorce, the grounds of complaint being desertion and failure to provide.
