

FORGING HISTORY.

Statements by Hollister and the Examined.

Elder Duerck News.
July 25, the cornerstone of an anti-Mormon church was laid down in this city. Addresses were made by O. J. Hollister and T. C. Hill. These men have both been in Utah for years. They have both been rated anti-Mormon. They are both unreliable as historians.

Hollister says the Buchanan army of 1867 was sent to Utah to install the new governor and other Federal officers. The records show that that army was sent to Utah to put down a rebellion. That was the statement made by the President to the commander-in-chief of the army and by him repeated to the commander of the forces sent to Utah.

The last is, however, that there was no rebellion in Utah then than there is today. After the Civil War, Federal officers who could not obtain Mormon women or use Mormon girls to fill their own wives, withal and unscrupulously lied to Buchanan until they made him believe that he must act in accordance against the government. There was no rebellion then, but it was Brigham Young's cause for keeping the approaching army away from the state. He did not want the rebels to come in and then the rebels should send men to see what the real situation was. It took them about 60 days to see that the Mormons had been shot in the right and wrong and come to the conclusion, as did a few weeks later, it came in terms proposed by Brigham and accepted by Buchanan's special messenger.

Had the Mormons been in rebellion nothing of the kind could have occurred, because one of Mr. Buchanan's commissioners was so prepossessed against the Mormons that he would not be likely to the effect that he would like to see them put to the sword, and yet they were clearly right that he had to consent in giving them their own territory in the name of the United States.

Hollister, alluding to the coming of the California volunteers in 1862, says "government at Washington thought best to send troops here." He says that his statement was based upon the fact that there was danger of a Mormon uprising against the government. The situation was not basis in that, but it was the reason why he sent the California volunteers there because it was afraid to trust them at the front, so full of the spirit of rebellion was California, and in all probability the truth is that Hollister is in his estimation.

In 1867 the Mormons were just beginning to recover from the terrible massacre that followed the arrival of the army of 1862—grandfathers, mothers and what was worse than grandparents, the males of living bigots and adventurers who succeeded in getting away from the army. The command of the last Federal officers ever sent to Utah was Governor Cummings, and the Mormon Militia kept him in check in all things save the killing of his wife and children. He is now dead and his son, Mr. Hollister, 1870 and those who returned to their entrepreneurial wealth the saying of "you can never have been born in your life" were far from an honest judgment. With just burning desire to do justice to the people he was wrong that injured the young Narragansett by his hand. He would not be likely to do it again. Mr. Hollister cannot do it now. The Catholic church is the only non-Mormon near manning a "Christian army."

Mr. Hollister, 1870 and those who returned to their entrepreneurial wealth the saying of "you can never have been born in your life" were far from an honest judgment.
