THROWN UNDER MOVING TRAIN.

Shocking Fate of James Lynch, a Young Tramp Who Was Stealing a Ride.

DEATH OF GEO. RANDALL.

Upon Citizen Succumbs to Typhoid Pneumonia—Court Cases.

Coalville, Summit Co., June 4.—The Tribune correspondent reports the death yesterday morning of George Randall at his home in Upton, after three weeks' illness. About a month ago he contracted a severe cold, which developed into typhoid pneumonia and cholera morbus, resulting in his death. He was about 45 years old and leaves a widow and five children, all girls, the youngest being 5 years old.
