SESSION OF CITY COUNCIL.

Sensation Sprung in Edwards Assault Case—Prisoner Held Under \$1,000 Bond.

FROST DOES MUCH DAMAGE.

New \$25,000 Theater for Ogden—Alleged Forgers Held for Trial—Nelson-Cross Nuptials.

Thomas D. Edwards was given a hearing before Judge Howell yesterday afternoon on the charge of assault with intent to commit murder, by cutting his wife's throat with a razor. The state was represented at the hearing by District Attorney Halverson, and the defendant by Attorney Joseph Chaz.

The testimony of a number of witnesses was taken, which went to show that the assault was made without provocation, and the defendant was held to answer to the charge to the district court under \$1,000 bonds.

The hearing, however, developed a little sensation. The defendant had, it is understood, been on bad terms with one E. D. Bello and a woman who posed as his wife, and they were the witnesses against him, but when Attorney Chaz came to cross-examine them, he asked the woman if she was married to Mr. Bello. The court instructed the witness to answer the question if it would in any way incriminate her, unless she desired. The woman thereupon refused to answer, which of itself was evidence enough for the jury, and they decided to immediately swear out a warrant for their arrest on the charge of perjury. But the fact that they would be arrested, and immediately on the dismissal of the court, they quickly went to the county court house and secured a marriage license in the name of E. D. Bello, aged 35, and Miss Catherine M. Edwards, aged 35, both of Ogden, and were married by John V. Bluth, Deputy Sheriff Sebring, was taking the prisoner to the jail when the couple leaving the court house. Through Bello marrying the woman they will both escape being prosecuted on a criminal charge.

HEARING OF ALLEGED FORGERS.

F. L. McAllister and John Derrigan had their preliminary hearing before Judge Howell on the charge of forgery, by forging the name of Mark Murphy to a check for \$15, which they cashed at the Hub Clothing store. The testimony was all of a convincing nature that the men under arrest were guilty of the crime, and they were bound over to answer to the district court under \$500 bonds each.

DAMAGE BY FROST.

The frost of the past few nights have done an immense amount of damage to crops throughout Weber, Morgan and Boxelder counties. Especially the frost has been heavy in Morgan county, as reported by people who came down to Ogden on the train. They say that the tomato, squash, corn and potato vines are frosted until they are black, that the tomato crop will be almost a total loss, and that Boxelder county comes a similar report. In Weber county the damage was not so great, and it appears that the frost has been in some parts than others. The potato and squash vines are badly frosted, and about one more night of such frost would almost destroy the tomato crop, but as it is the loss will be very heavy.
