PIONEER SQUARE

Can Be Sold By the City to James H. Bacon for Depot Grounds.

JUDGE ANDERSON SO DECIDES.

The Opinion Delivered in the Third District Court Today.

Shortly after the opening of the Third District Court this morning Judge Anderson delivered his opinion in the case of W. L. Vickard et al. vs. Salt Lake City et al., in which plaintiff's sought to enjoin the defendants from selling Pioneer Square to James H. Bacon. In the opinion it was ordered that the application for an injunction against the defendants be denied and the complaint dismissed.

The full text of the decision is given below:

This is an application by the plaintiff for an injunction to restrain the defendants from conveying any interest, directly or especially with one James H. Bacon, which would cloud or encumber the title of block 48, First Avenue, between 10th and 11th Streets, in Salt Lake City, Utah, and community units known as the Old Fort Block, or Pioneer Square.

The facts recited by plaintiff in his complaint are to the effect that he is a citizen of the United States, and that he is a resident of Salt Lake City, a taxpayer to the city, and owns real property therein consisting of one-half acre of land in front of himself and of all others who may hereafter choose to unite with him in the action.

Plaintiff also alleges that Salt Lake City is a municipal corporation created and existing under the laws of Utah and act of Congress, that the defendant George M. Smith is the recorder of said city, and that among the officers of said city is a council composed of fifteen members.

Bacon, for \$200,000, the sum of one hundred and fifty thousand dollars which may have been expended in the construction of the building, and that the same be sold to the highest bidder.
