ALLEGED DYNAMITER IS APPREHENDED

Captured in the Mountains Near Cherry Creek This Morning by Marshal Henroid and Two of McIntyre's Doughty Cowboys.

The Shot from Marshal Henroid's Winchester Brought Him to the Ground, Though He Was Not Hurt—Did He Act the Part of a Coward or a Cunning, Desperate Man, Who Was Trapped and Waiting for a Chance?—Does Not Deny the Crime—Conveyed to Eureka This Afternoon with a Team and Wagon Secured at Judge Powers' Mine—May be Brought to Salt Lake Tonight—Rejoicing Over His Capture

OFFICIAL TO THE NEWS: Salt Lake, Aug. 28.—(Special.) The alleged dynamiter, who was captured at Cherry Creek, near the border of the state, at 5 o'clock, this afternoon, was brought to Salt Lake City by Marshal Henroid and two of McIntyre's doughty cowboys.

According to all expectations, Marshal Henroid, the white-headed and grizzled old man, was expected to be shot dead by the dynamiter, who was waiting for a chance to kill him. But the dynamiter, who was a cunning and desperate man, was not hurt by the shot from the marshal's Winchester. He was only wounded in the arm, and he was able to get up and run away.
