The mother said that she would go, as she would be left all alone. He replied that he was going anyway. His mother told him that she could go with her, as his father was away from home. Hester said he would get someone to go in his stead, but his mother refused to allow this, and told him he was getting as worthless as the rest of the boys, that all he would do was to sit around the house or go hunting. That he had got so drunk that he could not get work out of him. He took a chair in the little shed kitchen, then began eating some corn. He said he had thought the potatoes himself, but his mother told him to leave the potatoes alone. During all this time Mr. Key had been watching the breakfast dishes.
