SHRINKLED INSURANCE COMPANIES

PITTSBURGH, Nov. 21.— Archibald Brewster, D. C., Nov. 21—Confidential sources say that Mrs. Price and a pretty woman were quite herself. Mrs. Holmes arrived in this city today in the custody of Detective Crawford, and Special Agent Perry of the Federal Marshals' office.

TORONTO, Nov. 20.— It is reported that the Japanese government has sent its reply to the note of Ambassador of the United States, asking for compensation for the damage done to the Japanese by the American Legation.

The official report of the great earthquake of Oct. 22nd in northern Japan shows that 2,100 houses were overthrown, 200,000 persons lost, 100 persons were killed, and 700 injured. The damage to property is estimated to be \$100,000,000.
