attempt of the French to break through the lines. During the assault yesterday on the German entrenchments, many French leaders displayed a reckless bravery, urging their men bravely without effect. In some instances the French fought with fury, evidently heightened by strong drink or other causes; but all the efforts of the leaders were in vain. The French, after firing, turned and fled, dropped on the ground and threw away their arms. The first dash, early in the morning, was made from the Bois de Boulogne towards the entrenchment opposite Fort Mont Redoubt, and was successful. The Germans fell back from their position, which was held by the French till evening. An immense mass of French kept pouring out, evidently concentrating for an attack on St. Cloud. At Versailles there was a tremendous commotion. Large bodies of picked troops moved to the front, and amidst the roar of the guns a general attack was made along the lines to the west and south-west. The advancing columns were met by a steady fire from the front, and the artillery in the rear kept up a constant shelling of the Bois de Boulogne. In the rear of the French lines the German troops, in several instances, followed them up, attacking the former in their position at Mont Redoubt. The whole French force withdrew upon the steps of Valer, under the shelter of its guns. A report is current that Trochu has asked for an armistice, for the purpose of gathering in the wounded; and officers on duty at the outposts say, large masses of men, dimly discernible with lanterns and stretchers, occupied the whole night at the mournful work. To-day the streets are filled with rumors of capitulation. The feeling is that the end is close at hand. The news of the defeat of Faidherbe's army, and probable annihilation of Bourbaki's army, strengthens the belief. In the morning a parliamentary commission was sent to Trochu, with the information of Faidherbe's capture, and the statement that this was the last desperate effort by the besieged. They say the men were disinclined to fight, and were driven to the front like sheep to the slaughter. An order was issued by Trochu, before the sortie, notifying the army that all soldiers retreating or shrinking would be shot, and a special guard was placed in the rear to carry out the provisions of the order. The troops were supplied with extra food and liquor.
