

## CONSPIRATORS SHOT TO DEATH

President Cabrera of Guatemala  
Himself is Authority for  
The Statement.

MAY BE MORE EXECUTIONS.

At Guatemala City There is Tranquility on the Surface But Conditions Are Serious.

Guatemala City, April 23.—President Cabrera himself is authority for the statement that 18 of the ringleaders in the conspiracy against him already have been shot to death and that probably more executions would follow.

President Cabrera, against whose life an attempt was made by students on Monday last, today received the representatives of the various powers and made a lengthy statement to them that he had unearthed an extensive conspiracy against him that led up to his attempted assassination. He declared that 18 of the leaders had been killed by his orders and that the death penalty would be meted out to others at the hands of the military. Among these are the men imprisoned a year ago. Having been implicated in a plot to assassinate the president, they were sentenced to death, but sentence had not been carried out. President Cabrera said that he had proofs that a majority of these prisoners were implicated in the new attempt against his life and that they would be executed without delay.

Although there is a surface tranquility here, conditions really are serious. The military is in control of the city and a partial suspension of business has resulted. The revolutionary feeling is strong in many quarters and there are those who will not hesitate to go to any length or face any danger in their efforts to make away with the president. Cabrera for this reason has been seen but twice or thrice in public in the last few months.

## SENATOR RAYNER DIS- CUSSES STATE'S RIGHTS

Washington, April 23.—State's rights was the subject of an interesting speech by the senator today by Senator Rayner of Maryland. Mr. Rayner spoke on his resolution declaring that in the opinion of the senate the powers delegated by the Constitution of the United States must not be enlarged by implication or encroachment upon the reserved rights of the states as guaranteed by the tenth amendment.

"The trouble with the president is," said Mr. Rayner, "and I always speak of him, not only deferentially, but with great personal respect, that he regards himself as vested with unlimited executive power under the Constitution."

"Some of our prominent leaders, with unrestricted admiration," said Mr. Rayner, "have applauded the president to the echo and in unmeasured tones have commended his revised edition of the Constitution of the United States. A wild and frantic host of hordes have poured forth in an adjoining chamber from Democratic bosoms as a message replete with the assumption of unlawful legislative authority resounded through the halls. If the president should be nominated by the next Republican convention, what will our spokesmen and orators say who have become the disciples of the states as guaranteed by the tenth amendment?"

Mr. Rayner favored a single presidential term and declared that no president should have the right to determine the selection of his successor through the use of federal patronage.

## J. THORBURN ROSS CON- VICTED OF STEALING FUNDS

Salem, Or., April 23.—J. Thorburn Ross, former president of the defunct Title & Guarantee Trust company of Portland, was this afternoon convicted of larceny of funds of the state of Oregon which had been placed in his custody, as president of the bank, by State Treasurer George A. Steel. The jury was out only 25 minutes. Sentence will be imposed Monday.

The state law provides as penalty for this crime imprisonment in the penitentiary for from one to 15 years, together with a fine equal in amount to the sum which the offender is proved to have stolen.

Investigations following the failure of the Title Guarantee & Trust company on Nov. 12 last exposed a condition of affairs that could hardly be conceived and for weeks the newspapers of Portland devoted column after column to charges of recklessness in banking that were appalling.

The case is of added interest because Ross has been a prominent member of the First Presbyterian church of Portland. Before coming to that city from Ohio about 20 years ago he was a Presbyterian clergyman. Failing eyesight compelled Ross to abandon the ministry.

## ROADS IN CANAL ZONE TO BE MACADAMIZED

Washington, April 24.—The department of municipal engineering is planning a complete system of macadam roads for the canal zone, and work on them is being pushed forward rapidly. On account of the large lake that will be formed by the dam at Gatun this road system naturally divides itself into two sections, one leading from Colon to Gatun at the north end of the lake and the other from Panama to Gatun at the south end of the lake. The road from Colon to Gatun will be about seven miles long and will be built some distance away from the railroad, in order to give the inhabitants of the zone an additional means of transportation.

In the vicinity of Panama there have been constructed since American occupation, about eight miles of macadam roads, four miles of which are on the Sabanas and four in the vicinity of Ancon and La Boca.

## YOUNG GREEK BOOTBLACK APPOINTED GREEK CRITIC

Chicago, April 24.—A dispatch to the Record-Herald from Alton, Ill., says: Thomas Kalendis, a bootblack in an Alton barber shop, whose perfect speech attracted the attention of Dr. B. G. Ray, classical professor in Shurtleff college, has been appointed critic of the Greek class in the college.

The boy of 18 is a graduate of the Athens, Greece, high school; is a student of ancient and modern Greek and proved himself so proficient in the ancient tongue that his services were demanded by the professor.

The boy gives half a day each week instructing the Greek students in accent and pronunciation. In exchange he has agreed to accept instruction in the English language, which he came to America to study.

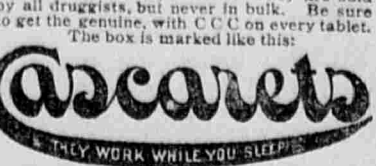

## COMMITTEE READY TO BE- GIN PAPER INVESTIGATION

Washington, April 23.—All members of the house today received telegrams from the publishers attending the annual meeting in New York of the Associated Press and the Newspaper Publishers' association, urging action on the bill regulating the tariff on print and wood pulp, and in reply John H. Sharp, Williams, the Democratic leader, sent the following:

"I join in your protest. Get the speaker to recognize me or some one else to make a motion and it will pass. It is up to him."

Representative Mann, who is chairman of the sub-committee appointed to investigate the paper question, said today that the committee was making preparations to begin its inquiry, but will go into the subject impartially.

He could not say just when the committee will begin its sittings, but said before doing so the members desired to inform themselves somewhat on the subject.

Speaker Cannon said: "The house has appointed a special committee, with the Hon. James R. Mann of Illinois as chairman, to make a full investigation touching the alleged combination of the manufacturers of print paper. I have no doubt that the committee is ready now to hear any member of the Publishers' association or the Associated Press touching any facts or suggestions by which facts can be ascertained that will shed light on the alleged combination. I might go further and say that I am satisfied that if these gentlemen don't give any of the facts on their own motion, they will be required to do so, and give such facts as they have to establish their claim."

## ALL BUT ONE OF FAMILY BURNED TO DEATH

Vancouver, B. C., April 23.—A dispatch from Battleford, Saskatchewan, says:

"Anna Matthews is the only survivor of a family of five, as a result of prairie fires in the Tramping Lake district. The father went to fight the flames, which were creeping down on their little home, and perished in the attempt. The house took fire, and Anna Matthews, 18 years old, with her clothes ablaze, carried her 5-year-old brother and sister to a place of safety returned for her but was too late. She fought her way again through the sea of fire only to find that the other children had wandered into the fire and perished."

## CONVICT CHEATED JUSTICE BY SUICIDE

Glenwood Springs, Colo., April 24.—John J. Taylor, convicted of second degree murder for killing his wife at Coal Basin, last August, and sentenced to 20 years in the penitentiary, cheated the court order by hanging himself in his cell at the city jail. He used a rope made of strips of his bedding. He was found shortly after midnight and had evidently been dead for several hours.

## FOR CONSULAR SERVICE. Chicago Wants Congress to Establish A School There.

Chicago, April 24.—Congress will be asked to establish in Chicago an academy for the education of young men for the consular service of the United States.

It was decided yesterday at a meeting of the executive committee of the Industrial club. This organization will take the initiative in arousing the national government to the importance of organizing such an institution.

The co-operation of the Association of Commerce and the National Businessmen's association has been assured. The Illinois Manufacturers' association and kindred organizations are expected to aid in the agitation.

Letters will be sent to Secy. of State Root, Senators Culver and Hopkins, and to the Illinois members of the house of representatives, outlining the purposes of the school, its importance to the export commerce of Chicago, and advancing the claims of Chicago, geographical and otherwise, as the logical location for the school.

## ICE CREAM FACTORY TO BE OPENED AT PANAMA

Washington, April 24.—Included in the "notes of progress," in the current issue of the Canal Record is the announcement that the commissary department of the canal commission soon expects to open an ice cream factory. An experienced ice cream maker from the states will be in charge and modern machinery and the most improved methods will be employed in its manufacture. All milk used will be brought from New York in cold storage. Beginning last Monday the commissary bakery at Cristobal was ready to furnish pies, pastry and rolls to all commission hotels, messes and employees in general, a complete pastry outfit having been installed with the most modern machinery.

## FATAL CYCLONE. Three People Killed, Number Injured. Many Houses Destroyed.

Bancroft, Neb., April 23.—A tornado swept through Cummings county and into Thurston county at noon today, and three people are known to have been killed a number injured, and a number of houses destroyed.

The tornado struck the house of John Mangelsen, near Pender, Neb., and then swept up into the air, taking the wreckage of the house and both Mr. and Mrs. Mangelsen. Both were killed, their bodies being carried a mile.

George Waeker and family were at lunch when the twister struck their house. Three of the family were seriously injured.

The dead body of a little baby was picked up in the public road 10 miles from Bancroft. The child has not been identified, but undoubtedly was brought by the tornado from some residence that was wrecked.

## FIVE FEET, FIVE INCHES. Civilian Applicants to Army Must be At Least That Height.

Washington, April 24.—No applicant from civil life for an appointment as an officer in the army will be accepted who is not at least 5 feet 5 inches in height. Also if such applicant is color blind for red, green or violet he will be rejected. The minimum for enlisted men is 5 feet 4 inches and there is no restriction as to color blindness.

The added inch and the visual requirements as applied to prospective officers from civil life, were made requisite in army orders issued today.

## TRAIN HOLD-UPS LOST THEIR NERVE

At Critical Time Courage Failed  
And Northern Pacific North  
Coast Limited Saved.

THREE MEN UNDER ARREST.

Two Admit Flagging Train but Say  
Armed and Masked Desperadoes  
Forced Them To.

Butte, Mont., April 24.—Lack of nerve at a critical moment caused the failure of a desperate attempt about 7 o'clock last evening to hold up the westbound North Coast limited at a point two miles west of Welch's spur and about 12 miles east of Butte on the line of the Northern Pacific. Rudolph Wenk, Paul Filenius and Al Teasdel are being held in the county jail here. Teasdel was found in the vicinity. Wenk and Filenius who are two wild-looking Germans, admit having participated in the flagging of the train, claiming, however, to have been forced to do so by two armed and masked desperadoes who, when the train had come to a halt, lost their courage and made a quick get-away. Filenius and Wenk walked to Welch's spur station, where they arrived and told of the affair just about the time M. J. Garrity in charge of the Northern Pacific's construction work, and a posse of four armed men, under Sheriff Henderson, arrived at the latter place. Both Wenk and Filenius, who are Germans and who speak broken English, declared that the bandits had 50 sticks of dynamite with them and that it was planned by the masked desperadoes to blow up a portion of the train to secure the money supposed to be aboard. A stick of dynamite was found on the top of a low bluff beside the cut in which the train was stopped.

What were supposed to have been the report of torpedoes, supposed to have been placed on the tracks were reports of shots fired at the engineer by the two bandits, according to the two Germans.

## WILL BE NO CUT IN PRICE OF DIAMONDS

New York, April 23.—Louis Abrams, president of the great diamond syndicate of international fame, which controls 98 per cent of the diamond output of the world, says that there is to be no shrinkage in the price of diamonds despite the fact that there is now a marked decrease in the demand for the precious stones.

Mr. Abrams is making his first visit to America, having arrived recently from his home in London.

"From having been the largest of consumers, you Americans are now buying practically no diamonds at all," said Mr. Abrams. "In consequence the mines within the last two or three months have been decreasing their output more than one-half."

"In my opinion it will not long be necessary to restrict the normal output of the mines. I believe the period of financial depression is not destined to be of long duration in America or anywhere else, and that within a comparatively brief time business will resume its natural equilibrium and America will move on in its destined career of prosperity."
