

bed. Did not see her till 7 o'clock next morning. Think she had then just come from Centreville. She spoke of having gone for a parcel. I saw her coming back, young Haskell Shurtliff with her, driving a double team. After breakfast she went to Farmington alone. About 9 o'clock she returned and then I first heard of the robbery. She went to Salt Lake with the team after that.

Court adjourned till this morning.

Proceedings this morning.

JAS CROSSLEY

Testified that he met Shurtliff between a quarter and half past seven in the evening of the 14th. It was a starlight evening but quite dark. He was on a grey horse. I went home, talking with him only a minute. I saw the train go past that night about half an hour after I passed Shurtliff. He was coming towards the city when I met him. I heard about the robbery next morning when I came to the city. I am positive I saw Mr. Shurtliff as I describe it. Mr. Shurtliff asked me about these facts about three weeks after the occurrence.

Cross-examination. I am a brewer. Have followed the business ever since I came to the country. I live about a mile or a mile and a half past the Hot Springs. On the evening of the 14th I saw the train as I passed my signboard to go up the hill to my place. I think this was about three miles from where I met Mr. Shurtliff. I met him near the Pa-coe Smelter. I had been selling beer in town that day. I left for home about seven. I remember comparing my watch with a clock in the city, and the latter indicated a minute or two before seven. Can tell from my memorandum book where I was on the 15th of August, on the 1st of September, etc., but not from memory. On the 13th of September I was in the city and sold beer to several saloon keepers. My recollection was first drawn to these events when Mr. Shurtliff called my attention to it between two and three weeks afterwards. I have no memorandum of meeting him that night. When he spoke to me about this meeting, he said he was accused of the robbery, and I said, "That was the night I met you." I have spoken frequently with him about it. I had met him many times on the road before that occasion. His horse was a white or gray. I was about two rods away from him. I did not discern any saddle. He neither told where he was coming from or where he was going. I have talked to lots of people about it.

Re-direct. I met Shurtliff a little way south of Shurtliff's slaughter house.

MRS. J. F. CRISMON

Was next sworn: Know Mr. H. C. Shurtliff. Remember hearing of a robbery in 1876. Saw Mr. Shurtliff at Mrs. Crismon's house the night of the robbery. I went there a little before eight o'clock. He came in about ten minutes later. Miss Cynthia Crismon was also with me in the kitchen. He went directly into the parlor and was there when I left. I only stayed a few moments. Miss Crismon and I left the house together, and went together to the corner. We should have gone to Ogden that day but did not go until the following Saturday. I saw Mrs. Shurtliff on Wednesday, the 13th, when we arranged to come up the following day. If we did not come a note was to be taken by Mr. Jacobs to her at Ogden. A parcel was also to be sent containing children's clothing.

Cross-examination. This was in September. I recollect the date because it was the day of the robbery. I have no memorandum. I heard Miss Crismon talking about a party in the 17th Ward that evening. I did not go. Mr. Stewart and Mr. Hardy were at Crismon's that evening. That is the only time I ever saw them there. I heard of the robbery the next day, and remembered then that I had seen Shurtliff the last evening. I very often thought about it afterwards. Do not remember what was talked about that night. Was married to John Crismon in February, 1878. Saw the bus, but do not recollect seeing light horses on it. It was going toward the depot. I went directly into the house after seeing Shurtliff's horse near the house. He (Shurtliff) came in between ten and fifteen minutes later. He said

"good evening, Miss Taylor," and passed into the parlor. I did not go into the parlor. Remember speaking about going to Ogden next day. I stayed about half an hour. I have talked with Miss Cynthia Crismon and with Mrs. Ellen Shurtliff about this case. Re-direct. When I went in I think it was about 8 o'clock, and when I came out the carriages were going to the depot. I think I stayed 15 or 20 minutes.

MISS CYNTHIA CRISMON.

Saw Mr. Shurtliff at the house after I went back home after accompanying Miss Taylor a short distance. He asked me for some tea as he was not feeling well. I wrote a note on Thursday the 14th to Mrs. Shurtliff that we could not come to Ogden till Saturday, and sent it by Mr. Jacobs the conductor. Miss Taylor and I did go to Ogden on Saturday and come home on Sunday evening. In this note that I wrote to Mrs. S. I told her that I would send things up.

Cross examination. Did not send the parcel, do not believe it was sent. I finished the clothing a few days afterward, and Mrs. Shurtliff came to our house for it and took it home. I saw Mr. Shurtliff at our house that evening, I think about 7 o'clock. I think he ate supper there. He went from the kitchen into the sitting room. I think Mr. Hardy came after Mr. Shurtliff came, but that Mr. Stewart was there before the others.

Re-direct.—I think I introduced Mr. Shurtliff to Mr. Hardy and Mr. Stewart. Am not positive that Mr. Shurtliff ate supper there. I heard of the robbery the night it occurred from a gentleman named Nichols, who was passing the house. He lived in one part of the house we lived in.

MISS GLOVER.

Lived at Farmington. In 1876 lived at Mr. Shurtliff's farm. Remember the wheat harvest of that year; on the night of the 14th of September, Mrs. Shurtliff and I slept in the same room. Mr. Shurtliff came in the afternoon and left for the city before Mrs. Shurtliff came from Ogden. She remained all night in the bed room in which she and I both slept. The next morning early she woke me up and went to Centreville, and we sent a buggy to meet her, and she afterwards went to Farmington.

Cross-examination. On the 16th of September, Mrs. Shurtliff was in the city. On the 12th she was not at the ranch. Have talked with Mrs. Shurtliff about this affair.

MRS. ALDER

Lived in the 17th Ward in September, 1876. Remembers a party given in the 17th Ward on the 14th of September, in pursuance of a resolution passed at a meeting of the Relief Society.

W. SCOTT CRISMON

Lived in Salt Lake City. Was at Calder's farm on the 4th of July, 1876. I went to a party in the 17th Ward schoolhouse on the night of the robbery. I saw Shurtliff that night. My mother and sister and Miss Taylor were at the house. Mr. Stewart and Mr. Hardy were introduced to Mr. Shurtliff. They came to our house a little after eight, and I went with them to the party. On the way to the school-house Mr. Hardy's nose began to bleed and while stopping for him to bathe it we heard the northern train come in. The next morning at the breakfast table I saw Mr. Shurtliff. On the day of and the day after the robbery I saw Mrs. Shurtliff at our house. I went up to Ogden on the Sunday after the robbery to go fishing.

The testimony of previous witnesses concerning the postponement of the fishing excursion was corroborated.

Cross-examination. I have never danced in the 17th Ward Schoolhouse since. Heard of the robbery the next day and remember distinctly that it was the 14th of September. Mr. Shurtliff came about 8 o'clock, and complained of having a pain in his side. He said he came down on a hard riding horse. Heard the locomotive whistle and the noise of the moving train.

MR. H. STEWART

Corroborated the testimony of Mr. Crismon respecting the party in the 17th Ward school-house.

MR. L. G. HARDY

Was sworn and testified to the same facts as the two previous witnesses. Recess till 2 p. m.




