**PORTLAND, May 1.**—No freight trains have been moving on the Union Pacific between Portland and Umatilla since Sunday, owing to a strike of conductors and trainmen on account of a reduction in wages. The conductors were cut down to \$2.75 and the brakemen to \$2 on the round trip. Manager Smith expects to have the trains moving tomorrow.
