PRE-HISTORIC RELICS.

A Collection of Mummified Skeletons and Portions of Human Bones.—Textile Fabrics, Etc.

Governor Thomas received the following interesting communication today:

Drummond, Colo., May 9th, 1892.
Hon. Arthur L. Thomas, Salt Lake City, Utah.

Dear Sir.—Understanding that you are interested in having the Territory of Utah secure a collection of the prehistoric relics to be found within her boundaries, I would like to call your attention to the fact that we have collected a few mummies from the cliff and cave dwellings of the southern part of the Territory. The collection is said to be fair, though it has not contained many fine specimens. There are two mummies, one male and one female, and we doubt if it can ever be duplicated.

The value of such sections is well known, and we were enabled to secure a class of relics that cannot be obtained from the rock art collections.

We collected some mummified skeletons and a large number of skull fragments, two distinct races. There are many samples of human hair, and some fine specimens of bone. Also a very fine selection of textile fabrics, pottery, stone, bone, and wooden implements, paints, spindle, needles, baskets, pipes, seeds, samples of clothing and ornaments, and many other articles.

I made a collection from the ruins of the city in the state, and sold the same to the Historical Society of the state. My wife will be glad to receive the antecedents of the collection to be made in this state at the World's Fair at Chicago. I also refer you to my collection of mummies, which was examined by the police.
