As soon as they get the water they are as fertile as any soil.

So far we have worked chiefly on the public lands, although adjacent private property will benefit. This land is turned over to settlers under a homestead act, although the old 100-acre allotment is not adhered to. The size of the lot is determined by its fertility, 20 or 40 acres.

The settlers take these lots with the understanding that they are to pay back to the government the cost of the irrigation improvements in 10 annual installments, beginning as soon as the water is turned on. They also have to pay the cost of maintenance, which amounts to 40 cents an acre. Under this arrangement the land is advanced by the government will be returned to it, and can be paid out again in other territories until all the arid lands have been made fertile.

KEMP BIGELOW'S CASE.
Motion to Quash New Cases Against Him Denied.

Denver, Colo., Nov. 27.—The motion to quash the new cases filed against Kemp V. Bigelow, who was sentenced to a number of prominent Denver men, argued today before Judge Byles, was refused.

Bigelow's attorney argued that after a jury had found the defendant guilty of simple assault in sending a bomb to David H. Moffat, he could not be prosecuted under similar charges, as the sending of the several bombs constituted one offense.

The court refused to sustain the motion and Bigelow will be tried on these other cases and also on the charge of attempting a confidence game. After the state authorities finish with him he will be turned over to the federal authorities.

AM. SILK CO. PLACED
IN HANDS OF RECEIVER.

New York, Nov. 27.—Being hampered by a lack of ready funds with which to continue its business, the American Silk company, which has a capital stock of \$1,000,000 and operates mills in several cities, was placed in the hands of a receiver today by Judge Ward of the United States circuit court.

The complaint stated that the American Silk company operates a large plant in Weehawken, N. J., and owns or controls the stock of the York Silk Manufacturing company at York, Pa., the Monarch Silk Company, a New Jersey
