THE OGDEN CEMETERY.

Major Turner's First Report on the Operations of That Institution.

The patient public of Salt Lake are wondering how long they will have to wait for the completion and operation of the city cemetery which caused so much talk in municipal circles lately. The interesting process of getting a garage in Ogden seems to be as unequalled success. Regarding it Mayor William H. Turner says:

"October 10th.

To the Hon. President and members of the City Council:

Gentlemen—Deliver please and state of work done by the city cemetery during the month of September, last. This is the second report on the operations made by the men in charge of the cemetery made in my name, my desire is that you keep correct account of all your acts and doings, and that you put this cemetery: 227 wagon loads of earth, 20 barrels of night soil, 16 boxes of manure, 10 boxes of lime, 10 boxes of ashes, 1 carriage of stones, 10 carriages of gravel, 1 wagon load of chips, 4 cars of sand, 10 boxes of lime, 5 bags spelled hay, 10 sacks of lime, 10 sacks of manure, making an average of about 100 cubic yards.

Cost of running cemetery for September was as follows:

Thirty-six days run, \$120 per day, for men in charge, \$1000.

One-half time and coal, \$100.

Total, \$230.

Average cost per cubic yard, about 27¢.

This cost can be considerably reduced if the public will use more care in keeping the disagreeable garbage away from the cemetery.

It is to be noted that the general health of the city is unusually good, great care is taken that nothing goes into the cemetery which would be injurious to the trees and bushes.

I have given these items in the papers and trust the information will reach the public.
