

# NOT PETTIBONE HAND WRITING

Letter Addressed to Thomas Hogan, the Original of Which Was Given to Orchard.

SO SHERIFF NICHOLS SAID.

Other Evidence Brought Out Very Largely Repetition of That in Haywood Case.

Rose, Ida, Dec. 16.—Documentary evidence in corroborations of Harry Orchard's testimony was introduced at the Pettibone trial today by the prosecution. Clarence Darrow, chief counsel for the defense, was taken sick last night and was not present in court during the day. Edgar Wilson taking his place, on account of Darrow's absence, Orchard was not asked impertinent questions, and the state postponed its redirect examination.

Judge Luther M. Caldwell was the most important witness for the state, being on the witness stand most of the time in session. He told of the finding of the bomb which Orchard testified had been planted near his gate for the purpose of killing him.

SHERIFF NICHOLS.

The testimony of former Sheriff Nichols of Caldwell proved spectacular of the state. After he had been called to testify, he was shown to Thomas Hogan, copying it, and giving the original to Orchard he testified on cross-examination that the letter was not in the handwriting of George A. Pettibone, the defendant. He said he became familiar with Pettibone's writing while the defendant was in jail at Caldwell. Orchard had testified that this letter was written in Pettibone. On direct examination Nichols failed to identify the handwriting of Haywood, with which he said he was also familiar, stating that it looked like that of Pettibone.

The state continued the introduction of corroborative evidence at the afternoon session. C. H. Wentz, bookkeeper for the Federal Mine and Smelter Company at Wallace, being called. He identified the signature of Jack Simpkins on the hotel register at Nampa, where he registered under the name of Simmons. J. C. Nichols, sheriff of Canyon county, at the time of the arrest of Orchard, took the stand and told of the receipt of a letter addressed to Thomas Hogan and postmarked at Denver. He made no copy of the letter, however, and was the original to Orchard, who put it in his safe after reading it. The copy of the letter was introduced. It was as follows:

"Dear Tom—That was sent to Jack Dec. 21, and ought to reach you by now. Let me know when you get to your new location." It was not signed. Nichols sent a telegram to Orchard, addressed to Thomas Hogan, and he told of Fred Miller coming to Caldwell to consult Orchard before his preliminary.

#### CROSS-EXAMINATION.

On cross-examination Nichols said he was in charge of the office at Caldwell when Moyle, the attorney and Pettibone, were confined in it, and that he examined the handwriting of each of them carefully. He said the writing in the letter which Orchard said came from Pettibone was not like that which the defendant wrote while in jail. On redirect examination the witness said he had never seen the letter and thought he would know the signature, but he could not identify the handwriting. When the witness was asked if he had given the copy of the letter written by Pettibone to Stearns, and it was given to him. After walking to his desk he handed the witness a letter and asked him to identify the writing. The witness said that as it was written in ink, and had seen him in lead pencil, he could not state positively, but he gave it as his impression that Pettibone wrote the letter. Both then showed that the letter he had given the witness was written by Haywood, he having switched them before giving it to the witness.

G. H. Hackett, local manager of the Western Union Telegraph company, produced an application for a money order from the Denver office. The application was signed by W. D. Haywood.
