MEXICO AND GUATEMALA.

Correspondence on the Boundary Dispute Published.

War Sentiment Still Growing High Strengthens the Republic—Soldiers Actions to Fight.

CITY OF MEXICO, Feb. 12.—Died Cifield, the Mexican official governmentally, this week begins the publication of the official correspondence between Mexico and Guatemala over the threatening international boundary dispute.
