W. H. KING.

Democrat, was one of the noted "Sagebrush" movers and has always evinced a preference for Democracy in some form. He represents the Sixth district and is President of the Council. He was born in Fillmore, but for some years past has resided in Provo, where he is a practicing attorney. Has held several official positions. His plurality over Booth (Rep.) and Mathews (Liberal) was 790.

HARBY HAINES,

Liberal, resides in Murray and he represents the Seventh district. He was born in Pennsylvania, received a liberal education and came to Utah seventeen years ago, where he has since remained. He was chosen over Eldredge (Rep.) and Smoot (Dem.) by a plurality of 478.

PETER GRAVES,

Democrat, is a resident of Ephraim, Sanpete county, and is 55 years of age, having been born in New Jersey in 1837. He has been a sturdy citizen and contributed no little to the building up of his community. Has not figured largely in politics, but is no stranger to it. He was elected over Lund (Rep.) and Martin (Liberal) by 210 plurality.

JAMES A. MELVILLE,

Democrat, hails from Fillmore and consequently represents the Ninth district. He was born in Iowa and is 40 years of age. Has held some minor offices in the neighborhood and served in the House of Representatives as a member two years ago. His plurality over Callister (Rep.) and Mathias (Ind.) was 765.

R. C. LUND,

Democrat, is and for the greater part of his manhood life has been a resident of St. George. He is 45 years old and a native of Wisconsin, but came to Utah when only three years of age. Has been mayor of that city, is now a Regent of the Descret University and has previously been in the Legislature, His plurality over West (Rep.) was 937.

THE HOUSE,

AQUILLA NEBEKER,

Democrat, is a native of this city, having first beheld the light of day here in 1859. He has spent his manhood years variously, being at the present time a stock raiser on a large scale. He has served two terms as prosecuting attorney of Rich county, and was elected to the House from the First district over Mr. Howell, his Republican competitor, by a majority of 711.

J. F. WRIGHT,

Democrat, also of the First district, is Bishop of Hyrum City, to which place he removed from Paradise a little less than a year ago. He is a thorough Cache valley man, having resided at various points in that thrifty section for over thirty years. He is in his 51st year. His majority over Mr. Dykins (Rep.) was 718.

A. H. SNOW,

Democrat, resides in Brigham City, that awful and is 38 years of age. He was born in this city, however. He has held times prom several offices of trust and profit in Box Elder county, besides having extensive business relations there and elsewhere. He was elected by a plurality of 182 son (Rep.)

over O. G. Snow (Rep.) and Barnes (Liberal.)

GEORGE ALLEN,

Democrat, represents the Third district and is recognized as a resident of Ogden, though he divides his time between this point and Evanston being a conductor on the Union Pacific railway. He was born in Belfast, Ireland, is thirty-four years old, and defeated withall (Rep.) and Maguire (Liberal) by a plurality of 46.

JAMES N. KIMBALL,

Liberal, is also a resident of Ogden and has been for several years. He is a native of Indiana and is forty-three years old. He was admitted to the bar when he was twenty-two years of age and has practiced his profession ever since. He was chosen over Dee (Dem.) and Clark (Rep.) by a plurality of 16.

NATHANIEL MONTGOMERY,

Democrat, is a resident of North Ogden, in the Fourth district. He was born in Upper Canada; fifty-one years ago. He has held several county offices and has once before served in the Legislature. His plurality was 187 over McKay (Rep.) and Taylor (Liberal.)

FRANK PIERCE,

Liberal, has resided in this city nine years. He is a lawyer by profession and served in the last Legislature. He is a native of the Green Mountain State, where he was born thirty-five years ago. His plurality in the late election was 1046 over Cushing (Dem.) and Harrington (Rep.)

HENRY W. LAWRENCE,

Liberal, is better known to the general public than any other member from this city, if not the Territory. He has been a resident here since 1850, and was born in Toronto, Canada, in 1835. He has been engaged in extensive business pursuits, chiefly of a mercantile character, and is at present Receiver of the Church property. His plurality was 1098, his opponents being Chambers (Dem.) and Critchlow (Rep.)

JACOB MORITZ,

Liberal, is a well known brewer of this city, and is forty-three years of age. He is a German, having been born in Rhenish Bavaria. He engaged in the brewing business at a very early age and has been engaged in it in various capacities ever since. He has been a resident here for twenty-one years. He had a plurality of 1019 over Richards (Dem.) and Cohn (Rep.)

WILLIAM H. IRVINE,

Liberal, was born in Knox county, Ohio, thirty-one years ago, and has resided in this city three years, coming here from Lincoln, Nebraska. He is a prominent real estate dealer and a member of the Chamber of Commerce. His plurality over Rawlins (Dem.) and Devine (Rep.) was 1096.

W. F. COLTON,

Liberal, is a Philadelphian, and is 51 years of age. He was in the Union army during the last three years of that awful conflict, and was several times promoted, emerging as a captain. He is a prominent railroad man and is connected with the P. V. coal enterprise. He was elected by a plurality of 1089 over Bush (Dem.) and Carlson (Rep.)

JOHN A. MARSHALL,
Liberal, the well known lawyer of this
city, is a native of the Old Dominion,
and has resided here a dozen years or
thereabout. He was appointed Probate
Judge of this county by President
Cleveland in 1888, but held the office
only about a year when he resigned
and devoted his time to the practice of
his profession. His opponents in the
election—Smith (Dem.) and Treweek
(Rep.)—were defeated by a plurality of
1142.

DAVID STOKER,

Democrat, represents the Sixth district. He is 48 years of age and is a native of Hancock county, Illinois, residing at present and for a long time past at Bountiful, Davis county. Has held the positions of selectman and probate judge, and is one of the foremost citizens of that community. His plurality was 592 over Porter (Rep.) and Edholm (Liberal.)

GEORGE CUNNINGHAM,

Democrat, is also a Scotchman, having reached this mundane sphere at Fifeshire on the 16th of August, 1840, and coming to this country when 16 years of age. This makes him almost a pioneer. He resides in American Fork and represents the Seventh district. He is mayor of his city and was one of the noted "Sagebrush" Democrats when that movement was in vogue over three years ago. Hts plurality was 423 over Robinson (Rep.) and Christenson (Liberal.)

JOHN C. MACKEY,

Democrat, is another native of this city, where he was born Nov. 30, 1857. He graduated at the Deseret University, and has been engaged in mercantile pursuits, but is at present a farmer and sheep raiser. He was eleted over Canton (Rep.) and James (Liberal) by 564 plurality.

M. F. ANNETT,

Democrat, representative of the Ninth district, is a Virginian, and is about a third of a century old. He graduated as a lawyer from Columbia college, but is at present engaged in mining at Bingham. He was opposed in the election by Richards (Rep.) and Legg (Liberal), but walked off with the prize 118 ahead.

E. P. FERRY,

Liberal, represents the Tenth district and resides in Park City, but hails from the Wolverine State. His chief occupation is the mining business and he is very well known. His plurality was 336 over Boyden (Dem.) and Buchanan (Rep.)

W. R. PIKE,

Democrat and doctor, is a resident of Provo and has been for many years. He has looked upon this world for forty-lour years, all but sixteen of which have been spent in the United States. He is and ever has been thoroughly in sympathy with his party, being also a "Sagebrusher," but this is his first official experience in the line of politics. He had a plurality of 374 over Sutherland (Rep.) and Hill (Lib.)

J. D. IRVINE,

Democrat, is another Scotchman, hailing from Glasgow where he was born in 1855. He came to Salt Lake City at an early age, but has since resided variously further south, for some years being a resident of Payson. His opponents were Page (Rep.) and War-
